

## Surface Commingling - Sanderson A Lease and Sanderson AB-14 Lease

Commingling Order PLC-65 gave Conoco Inc. permission to surface commingle our Sanderson A Lease and Sanderson AB-14 Lease with the provision that we separately meter production from each lease. We are requesting this order be amended allowing production to be allocated by well tests.

The provision that we meter production was due to the Sanderson A Lease having sliding scale royalty and the Sanderson AB-14 Lease having step-scale royalty. We do not feel this will be a problem as the Sanderson AB-14 lease would have to produce more than 50 BOPD to create a difference in royalty and this is highly unlikely. The production from the Sanderson AB-14 lease is marginal and we cannot justify the cost of metering so this 7 BOPD well would have to be shut in.

We are attaching an approved copy from the Bureau of Land Management allowing us to measure production from these leases based on well tests.

Your consideration of this matter will be very much appreciated.

Application for Permission to Surface Commingle Production from the ERVATION DIVISION Sanderson A Lease with Production from the Sanderson AB-14 Lease SANTA FE

Conoco Inc. requests approval to surface commingle production from the Eunice-Monument (G-SA) and Eumont Yates Seven Rivers Queen on the Sanderson A Lease with production from the Sanderson AB-14 Lease, a one-well lease which produces from the Eumont Yates Seven Rivers Queen. Please note Administrative Order No. PC-604, dated August 28, 1981, provided NMOCD approval to surface commingle the two zones mentioned above on the Sanderson A Lease, basing production on well tests; the United States Geological Survey provided the same approval on October 31, 1981.

A summary of production is given below.

The working interests and overriding royalty interests are common between the two leases, but the federal royalty differs. The Sanderson A Lease has a sliding scale royalty, and the Sanderson AB-14 Lease has a step-scale royalty. Despite this fact, Conoco Inc. still requests production from both leases be based on periodic well tests since production from the Sanderson AB-14 Lease is marginal.

In addition, attached are the following: a letter to ARCO Pipeline Company which will serve as notification to the purchaser of our commingling proposal, a schematic of our commingling proposal, a letter of notification to the non-operating working interest owners and a map showing the location of all wells which will produce into the commingled battery.
