Gentlemen:

Phillips Petroleum Company requests administrative approval to amend Commingling Order PLC-No. 76 Authorization for the Leamex Lease and Philmex Leases by adding State "E" TG and State "F" TG Leases. All of the State "E" TG and State "F" TG wells produce from Grayburg/San Andres formation. Currently the State "E" TG and State "F" TG wells are commingled at the tank battery, located NW/4 NE/4 of Section 36, T-17-S, R-33-E, Lea County, New Mexico. This tank battery will be eliminated upon approval to surface commingle these wells, thus decreasing operating expenses associated with the battery. Pertinent information and data are included herein:

Production for all leases involved is produced from Grayburg/San Andres formation.

Determination of production from each well will be provided by well tests with the exception of State "E" TG Lease, which will be metered.

All leases to be commingled share a common working interest, royalty interest, and overriding interest with the exception of the State "E" TG Lease.

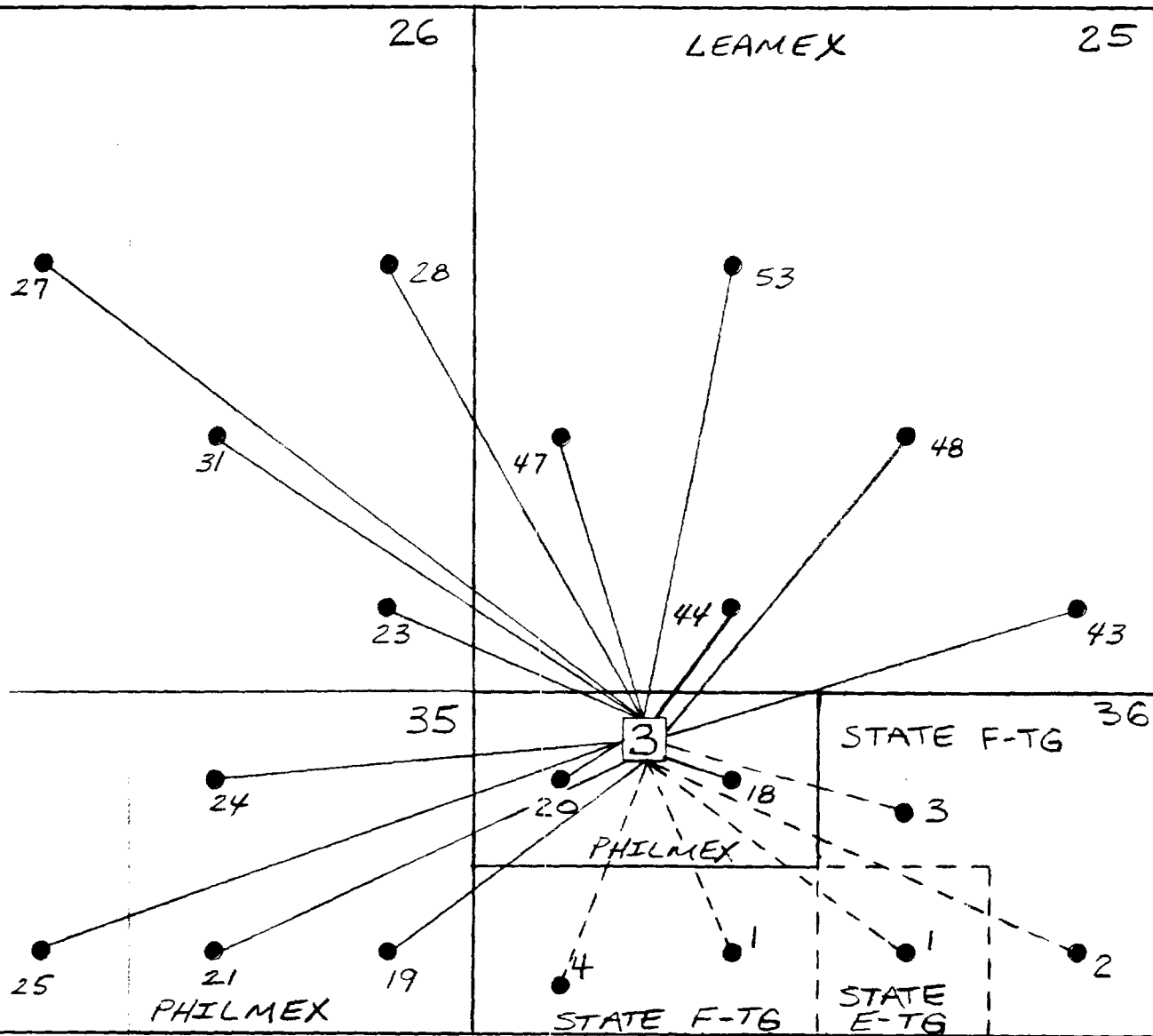

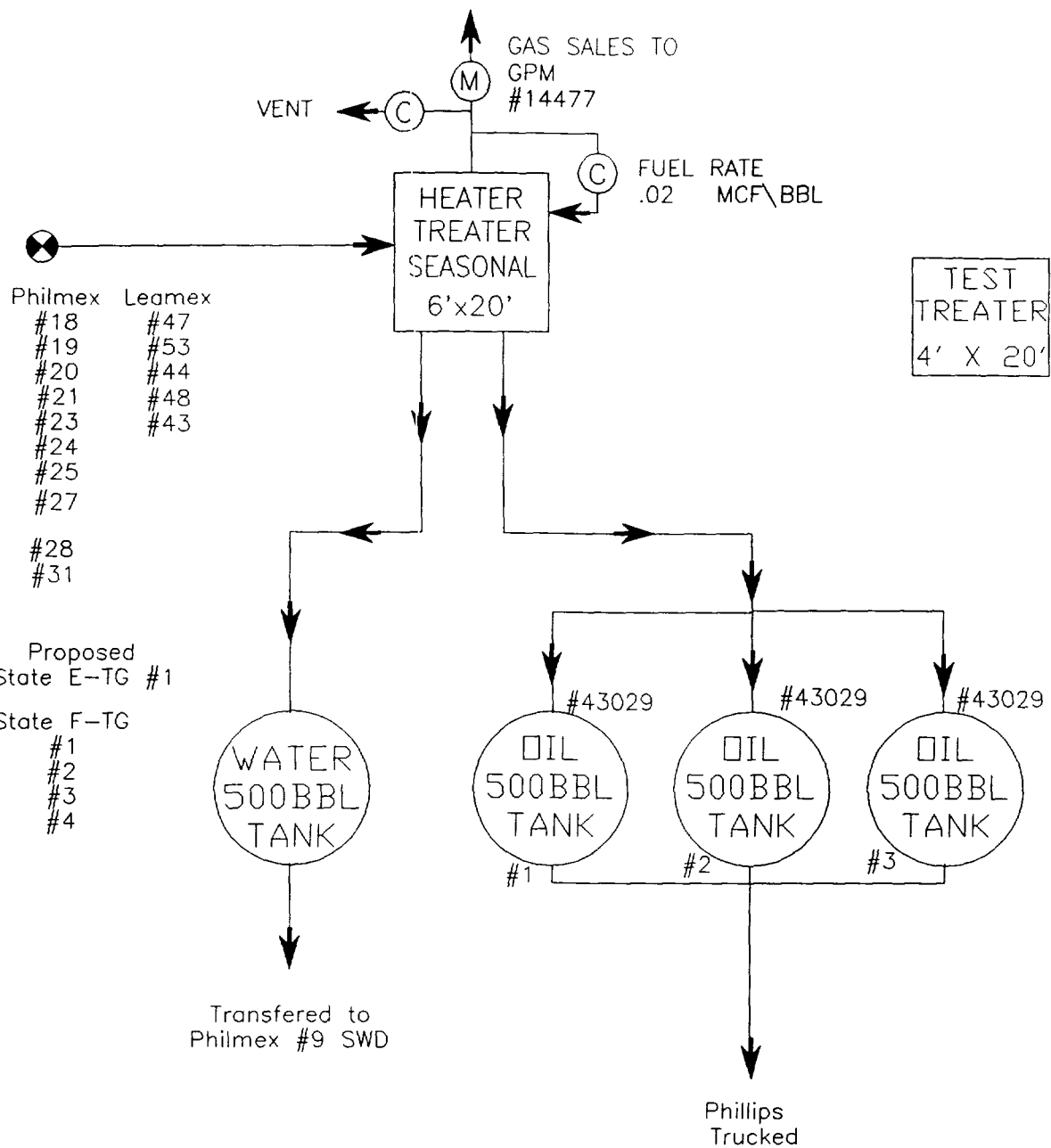

Dear Mr. Sanders:

This office is in receipt your application to surface commingle the State F-TG Well Nos. 1 thru 4 (B-2229) and the State E-TG Well No. 1 (B-8398) , into the Philmex No. 3 Tank Battery located in the N/2NW/4 of Section 36, Township 17 South, Range 33 East (B-2229-1).

According to your application twenty wells producing from the Grayburg San Andres formation will be commingled at the Philmex No. 3 Tank Battery.

Since ownership is common throughout and there will be no loss of revenue to the State of New Mexico's Beneficiaries from your proposed operation, the Commissioner of Public Lands, this date approves your request. Our approval is given with the understanding that the Commissioner of Public Lands reserves the right to amend or withdraw his approval should this operation prove to be unprofitable to the State at any time in the future. Our approval is subject to like approval by the New Mexico Oil Conservation Division.
