Amoco Production Company respectfully requests an administrative approval for an unorthodox location for the Gallegos Canyon Unit Well No. 566 to be drilled at a location of 2150 FNL and 1340' FWL of Section 28, T29N-R12W. An unorthodox location in the N/2 of the section is necessary to recover subsurface resources in the area since an orthodox location can not be obtained due to the existence of the San Juan County Fairgrounds (McGee Park) which encompasses a major portion of the section. The location of the Park, the race track which is located in the NE/4 and US Highway 64 which cuts through the northern portion of the quarter is indicated on the attachment marked as APD Map #1.

To aid in your review attached is a C-102 Well Location Plat showing the well location, a topographical map identified as APD Map # 1, and a 9 section plat showing the offset wells.

Amoco Production Company is the only affected offset operator, therefore, no further notification is necessary.

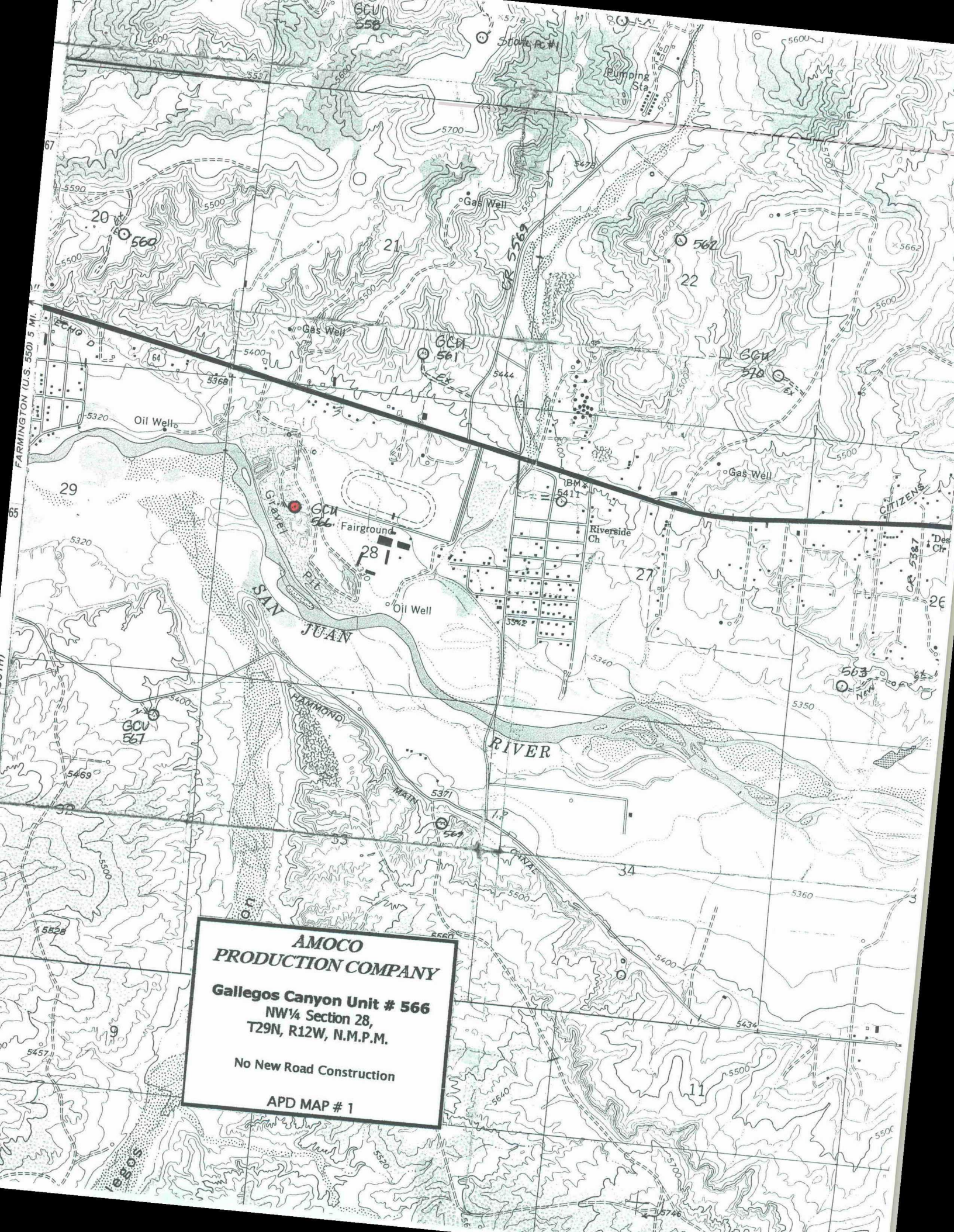

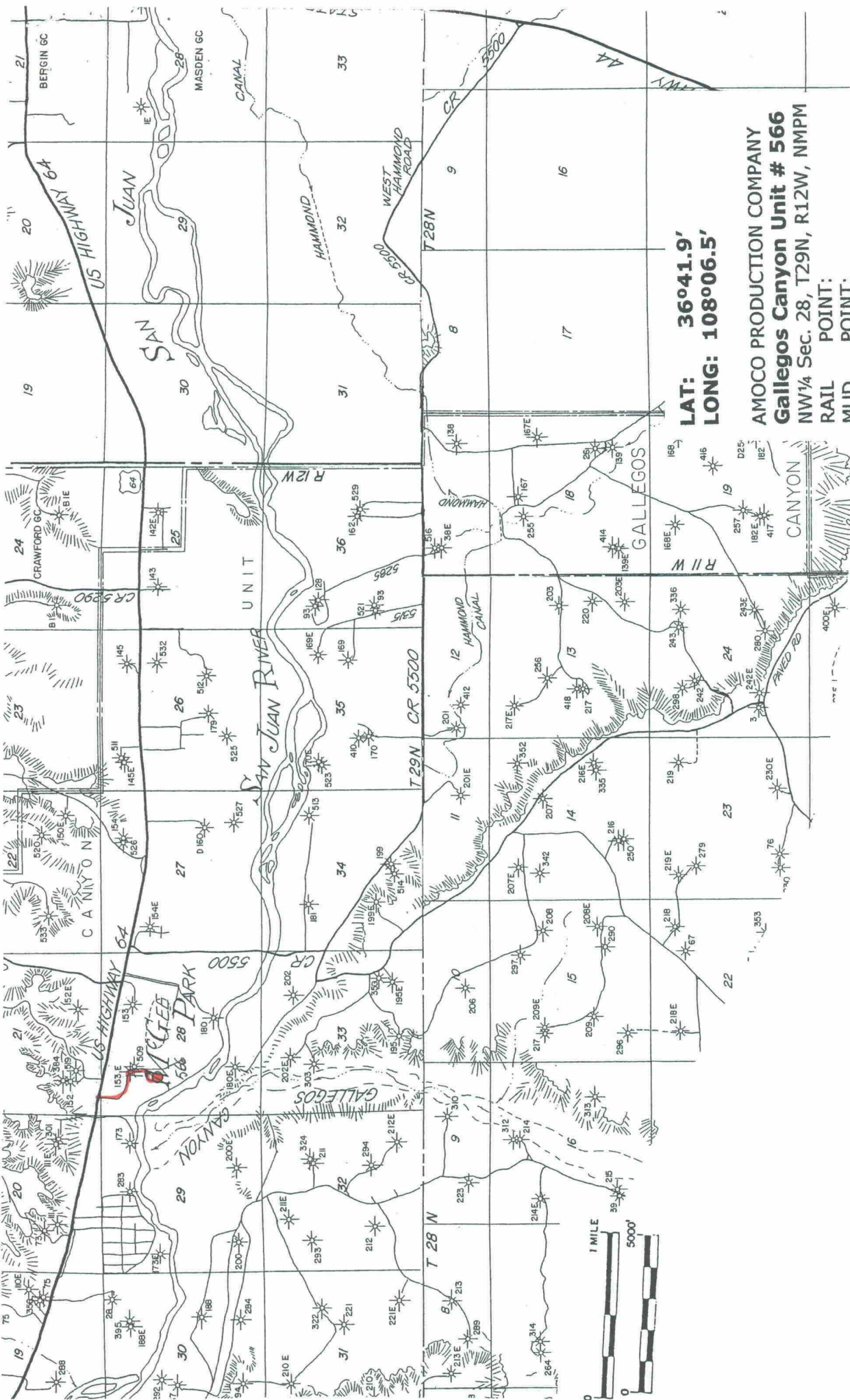

APD MAP # 1

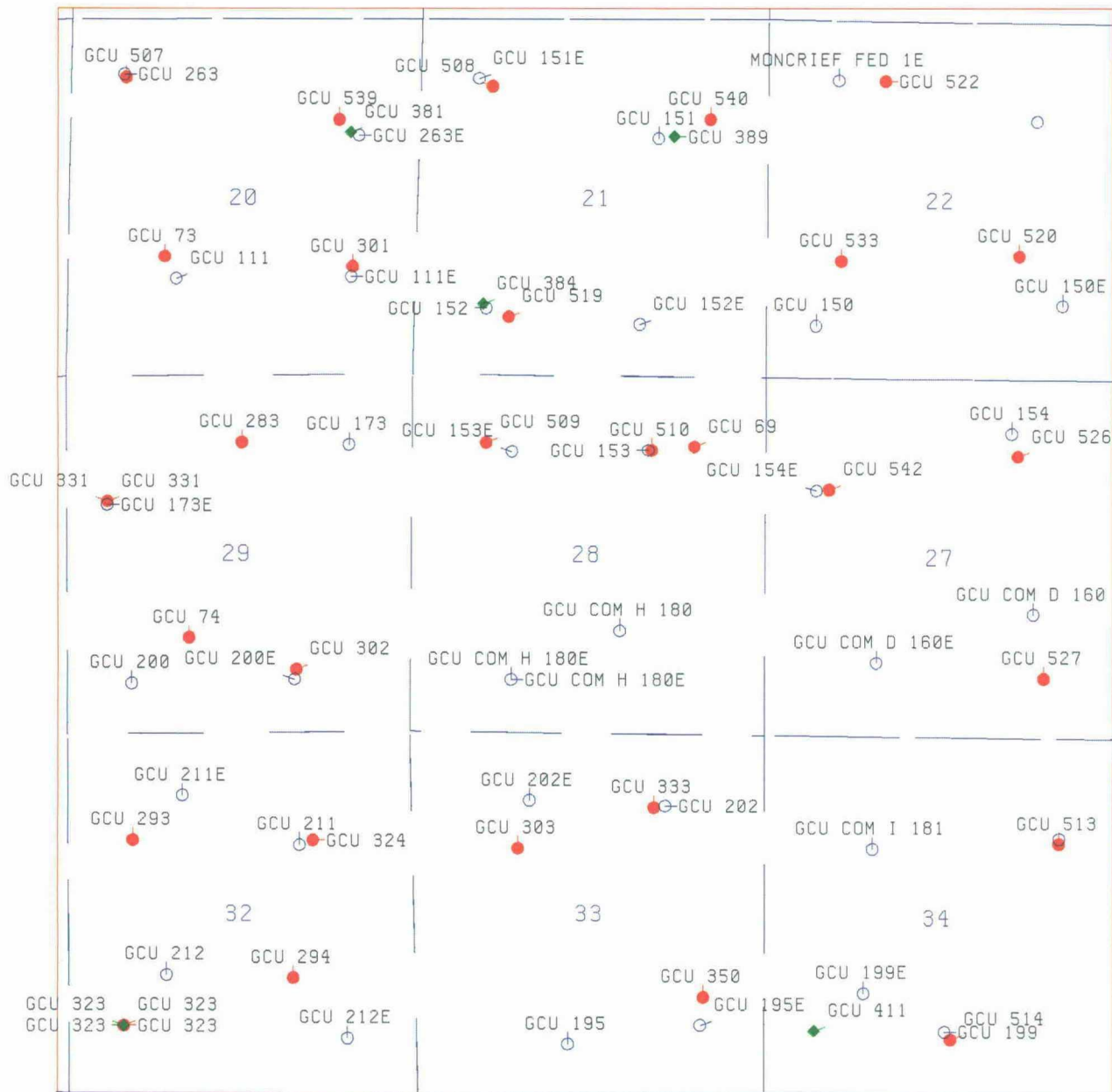
