Cross Timbers Operating Company hereby requests administrative approval for an unorthodox location for the above referenced well. Attached for your reference are the following exhibits:


1. Well location plat (NMOCD Form C-102)
2. Ownership map
3. List of Offset Owners

The above captioned well was spud on 10-28-65 and completed on 11-23-65 as a E/2 320 acre unit Dakota formation and has produced until 1994 at which time the well was shut-in. Cross Timbers Operating Company would like to move up the hole and recomplete the well in the Angles Peak-Gallup Associated Pool formation. The rules state that the well should be spaced no closer than 790' to any quarter section line, nor closer than 330' to quarter quarter section line. Due to the expected small oil production the Gallup would need to be on an 80 laydown spaced unit. The existing location would not conform to current spacing in either the 320 acre unit or the 80 acre unit. A new location to obtain the minimum distance for spacing can not be made due to the location of the existing wellbore. A new well would not be economically feasible to drill for just the Angles Peak-Gallup Associated Pool formation. The current wellbore is in acceptable condition for the recompletion attempt with no additional work being required. By moving up the hole, Cross Timbers would be able to minimize environmental impact in obtaining additional production and protection of correlative rights.

By certified mail, a copy of this application and request for administrative approval has been sent to all of the Angles Peak-Gallup Associated Pool formation working interest owners and offset operators listed on the attached list.

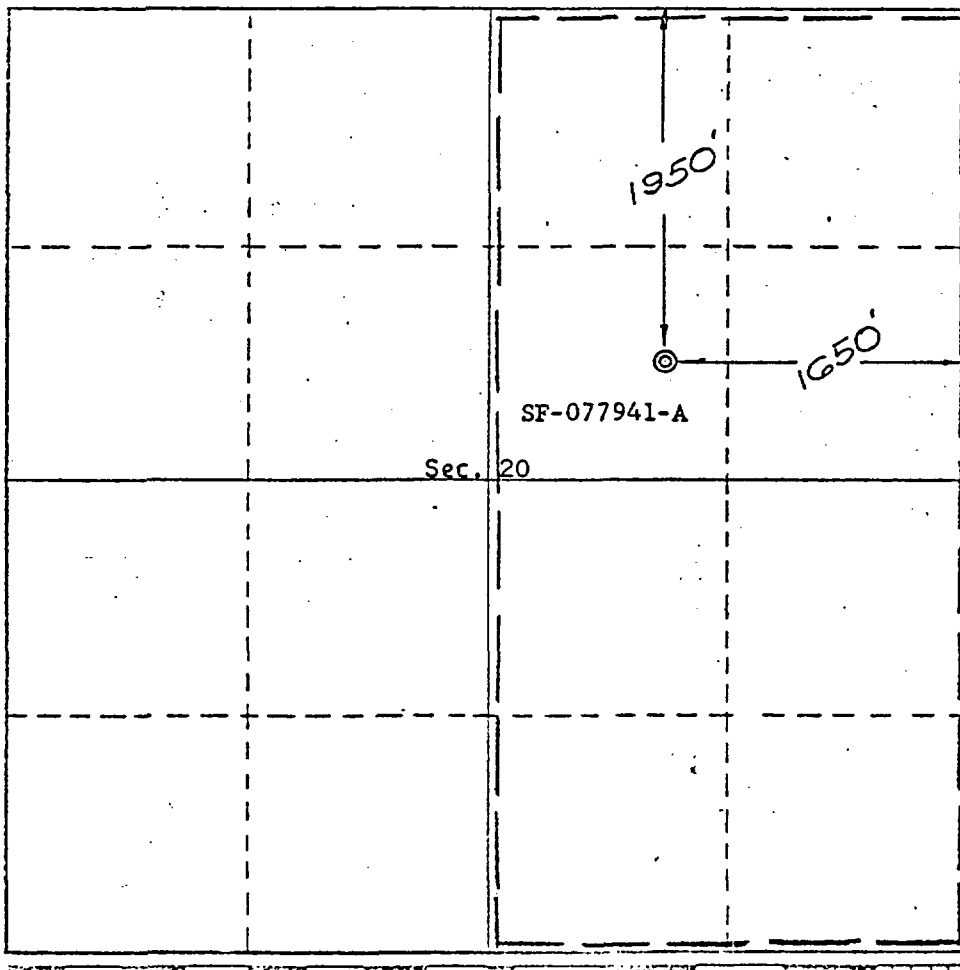

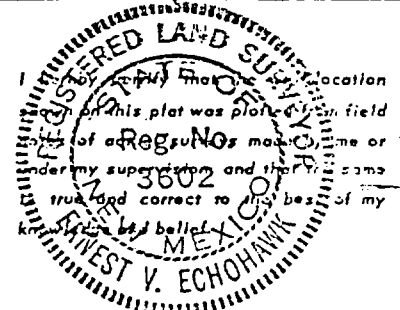

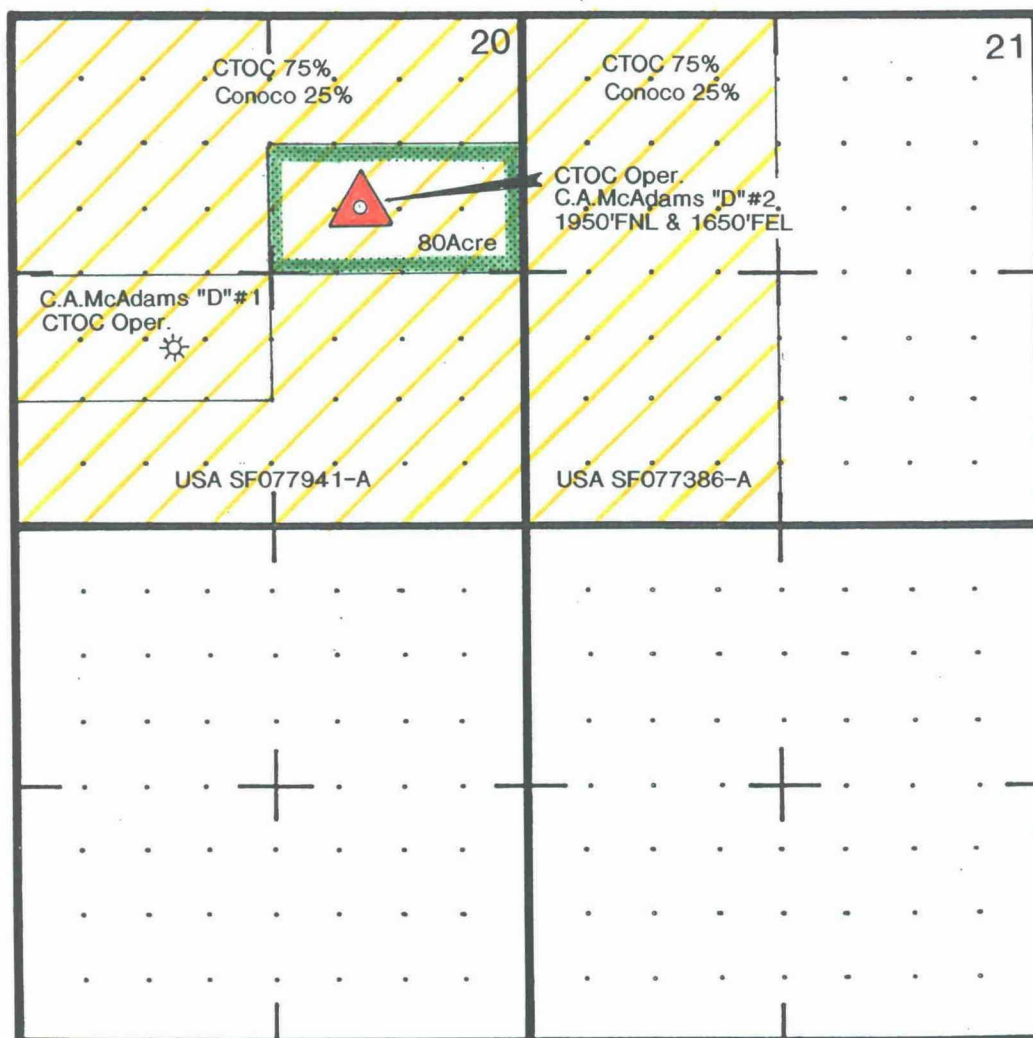
