Gentlemen:

Premier Oil and Gas hereby requests administrative approval to drill our Dale H. Parke "D" No. 10 at an unorthodox location of 2480' FSL and 330' FEL in Section 15 of Township 17 South, Range 30 East. This well has been approved by the BLM to a depth of 6000 feet. If a successful well is completed, it would be a Loco Hills Paddock producer. The orthodox location impacted an existing Duke Energy high-pressure gas pipeline. The pipeline is a northwest to southeast route. Premier attempted a move to the south, but due to the angle of the pipeline, a southwardly move required impacting other proposed Paddock wells. Premier then moved to a location north of the pipeline, but unorthodox. Plans were then made to drill the orthodox location (Dale H. Parke D No. 11) first. This has been done and confirmed that a move to the south side of the gas line would impact drainage area of the Dale H. Parke "D" No. 11. Therefore, requiring submittal of this application. 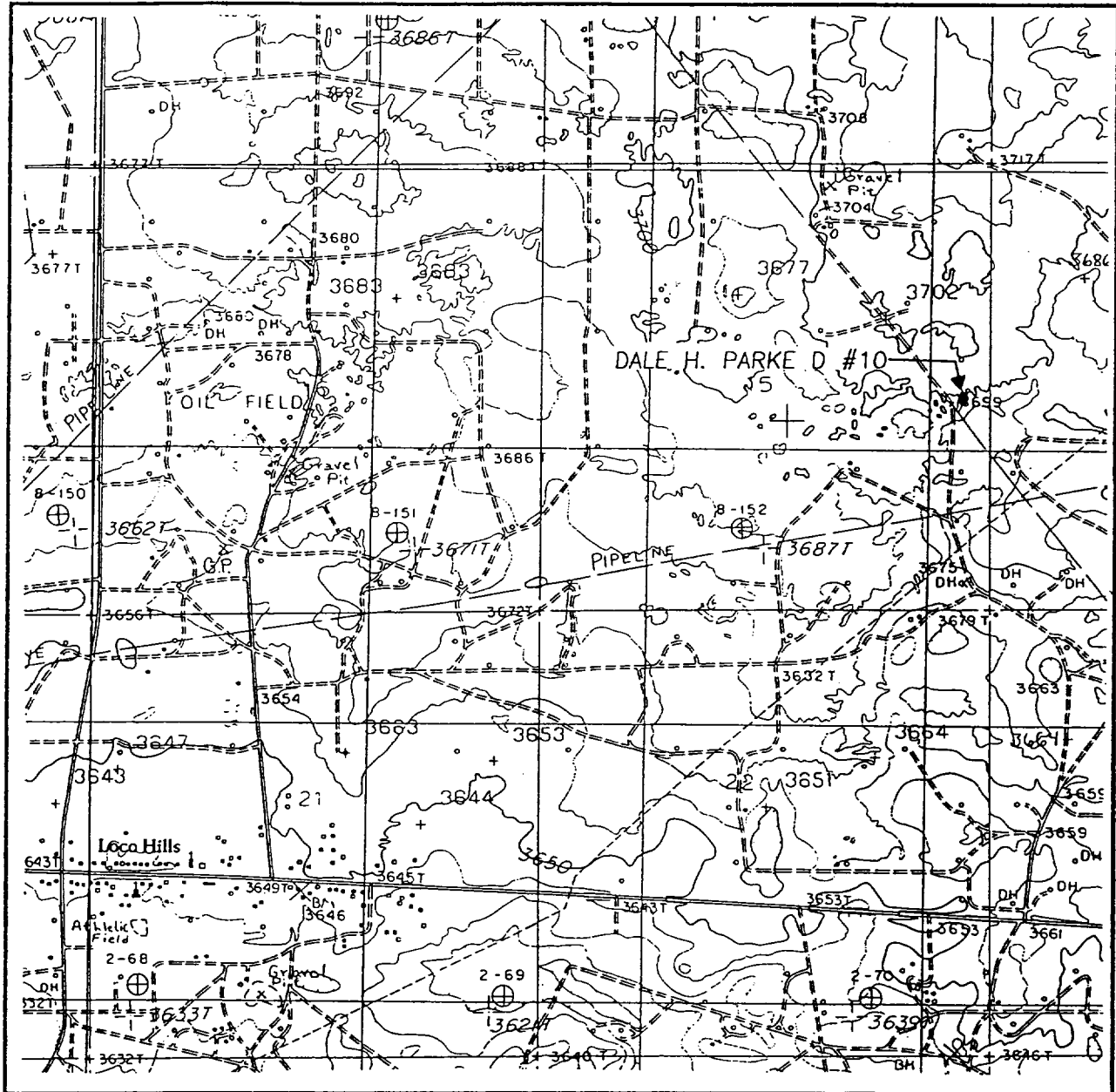

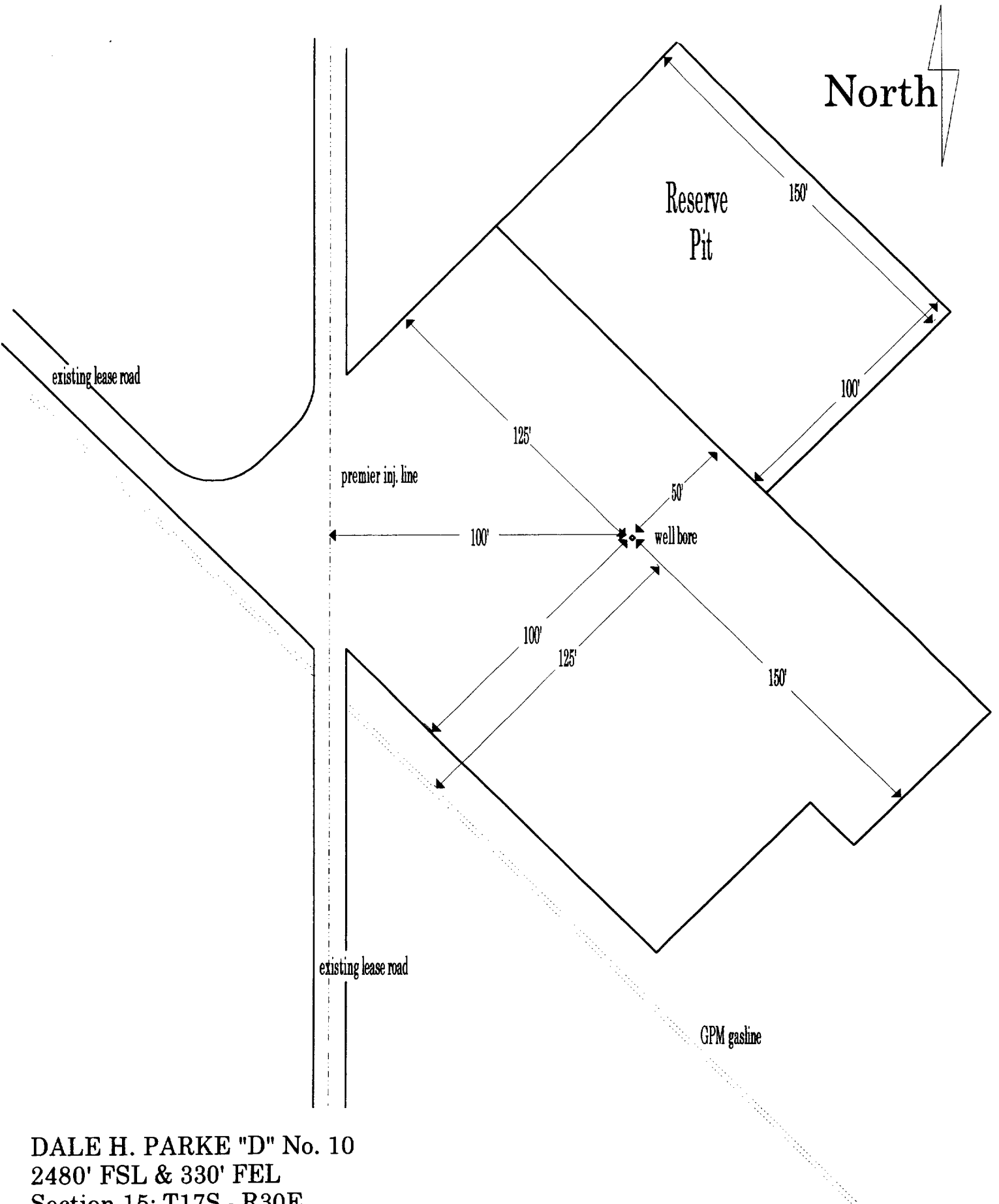
