Mack Energy Corporation respectfully requests an administrative approval without notice and hearing of the following unorthodox well location.

Because of our desire to drill this well in a timely manner, we also request your approval be expedited. The well location and legal description is as follows:

1115 FNL & 330 FWL
Sec. 29, T17S, R29E
Eddy County, New Mexico*

The well will be completed in the Paddock formation in the East Empire Yeso Pool.



Moving the location 125' to the south will give the distance needed to build a location away from the pipeline. The location would have fallen too close to the highway if it was moved north to get away from the pipeline to make it orthodox. There are no other possible orthodox locations for this well due to existing locations being located on 10-acre spacing.



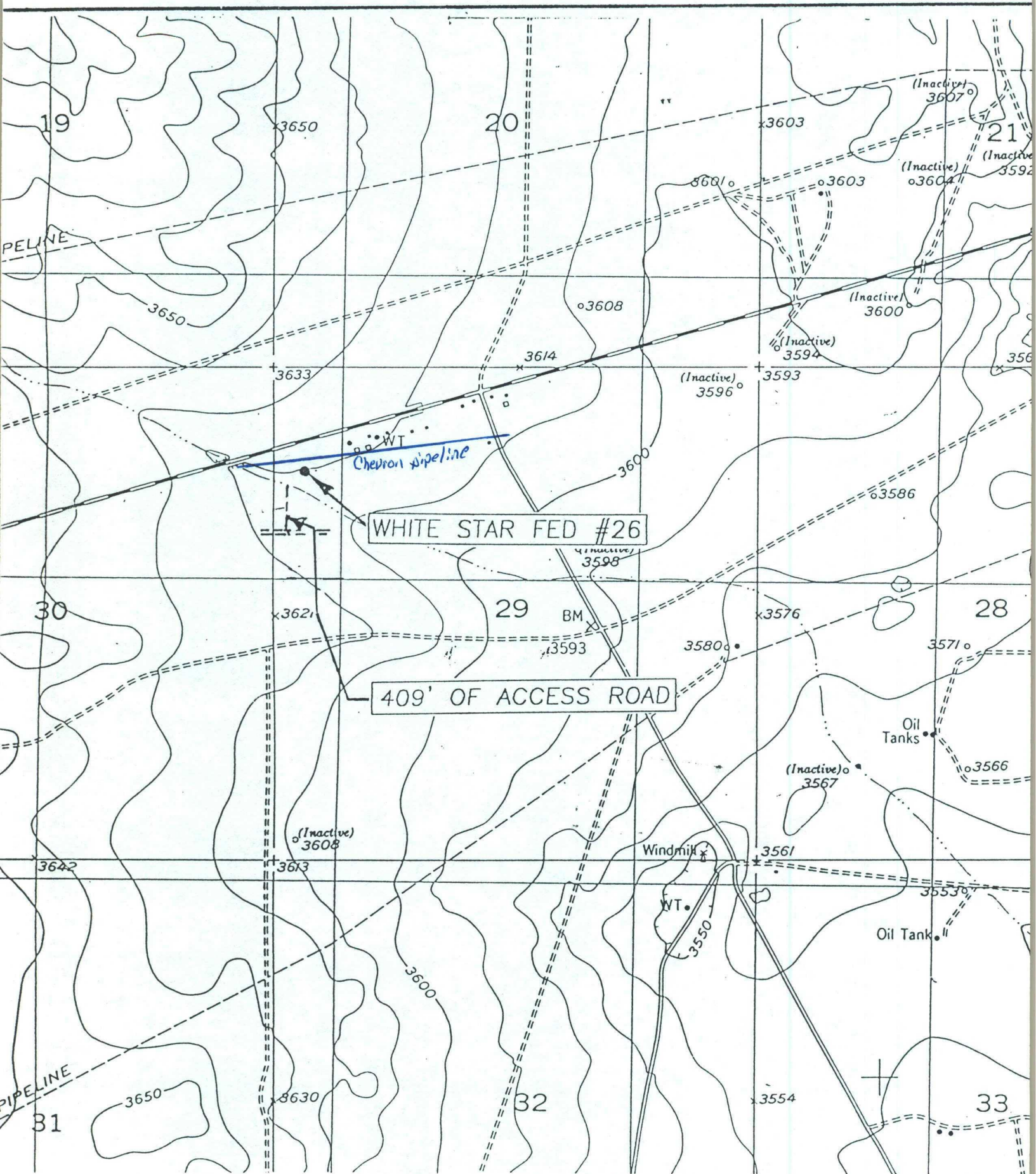
