Gentlemen:

Reference is made to your application for approval of a 120-acre non-standard gas proration unit in the Blinbry Gas Pool consisting of the following acreage:

Township 22 South, Range 37 East, NMPM  
E/2 SE/4 and NW/4 SE/4 of Section 23

It is understood that this unit is to be ascribed to your A. M. Lee Well No. 1, located 1980 feet from the south line and 660 feet from the east line and in the NE/4 SE/4 of Section 23, Township 22 South, Range 37 East, NMPM, Lea County, New Mexico.

By authority granted me under provisions of Rule 5, Section (b)-6 of the Special Rules and Regulations for the Blinbry Gas Pool, as set forth in Order R-610, you are hereby authorized to operate the above described acreage as a non-standard gas proration unit, with allowable to be assigned thereto in accordance with pool rules, based upon the unit size of 120 acres. The allowable shall be effective the first day of the month following receipt of an affidavit from you containing the signatures of all working interest owners who have consummated a communitization agreement. This notification shall be sent to our Hobbs office with a copy to the Santa Fe office.


