
Gentlemen:

STATEMENT OF INTENTION:

The North Shore Woolworth No. 3 well was originally completed in May, 1939, as a Queen Sand Oil Producer in the Langlie Mattix Pool. In March, 1941, this zone was plugged off and the Yates zone at 3078 to 3200 was perforated and completed for 8,000 M.C.F.G.P.D. on open flow. This well was then assigned an allowable as a Langlie Mattix gas producer.

By Commission order on July 6, 1956, this well was reclassified as a Jalmat gas well.
