Gentlemen:

Reference is made to your application for approval of a 80-acre non-standard gas proration unit in the Tubb Gas Pool consisting of the following acreage:

Township 22 South, Range 37 East
N/2 SE/4 of Section 13

It is understood that this unit is to be ascribed to your E. Butler "B" Well No. 1, located 1980 feet from the South line and 660 feet from the East line and in the NE/4 SE/4 of Section 13, Township 22 South, Range 37 East, NMPM, Lea County, New Mexico.

By authority granted me under provisions of Rule 5, Section (d)-6 of the Special Rules and Regulations for the Tubb Gas Pool, as set forth in Order R-586, you are hereby authorized to operate the above described acreage as a non-standard gas proration unit, with allowable to be assigned thereto in accordance with Rule 12 of the pool rules, based upon the unit size of 80 acres.
