Mr. A. L. Porter:

Tidewater Oil Company hereby makes application for approval of a non-standard gas proration unit comprising the N/2 SW/4 and the NW/4 of SE/4 of Section 32, T19S, R37E, Lea County, New Mexico, and in support states as follows:

*well  
in NW/4SW/4*  
(1) Tidewater Oil Company and Amerada Petroleum Corporation have communitized the N/2 SW/4 and the NW/4 SE/4 of Section 32, T19S, R37E, Lea County, New Mexico and wish to form a 120 acre non-standard gas proration unit.

(2) In order to obtain production of gas-well gas from the Eumont formations underlying the proposed non-standard gas unit, Tidewater has recompleted their State "H" No. 2 well, located 1980' NSL and 1980' EWL, Section 32, T19S, R37E. *(C-APISLO/Mr. Porter)*

- (3) There are no other wells on the proposed unit acreage which are completed within and producing from the vertical limits of the Eumont Gas Pool.
- (4) The proposed non-standard gas proration unit will meet the requirements of Rule 5 (b) of the Oil Conservation Commission Order No. R520 as follows:
  - (a) The non-standard gas proration unit consists of contiguous quarter-quarter sections.
  - (b) The non-standard gas proration unit is wholly within a single governmental section.
  - (c) The entire non-standard gas proration unit may reasonably be presumed to be productive of gas in the Eumont Gas Pool.
  - (d) The length or width of the unit does not exceed 5,280 feet.
  - (e) By copy of this application, all operators owning interest within 1500' of the proposed unit will have been notified by registered mail.
  - (f) A plat showing acreage to be dedicated, well location, and offset ownership, is attached.

In view of the facts herein stated Tidewater Oil Company requests that the above described non-standard gas unit be approved and 120 acre unit allowable be assigned, effective on the first day of the month next succeeding the month in which this application is approved, or the date of filing of Form C-104 and Form C-110 and the gas-well plat on the Tidewater State "H" Well #2, or the connection of said well to a gas transmission line, whichever is the later.

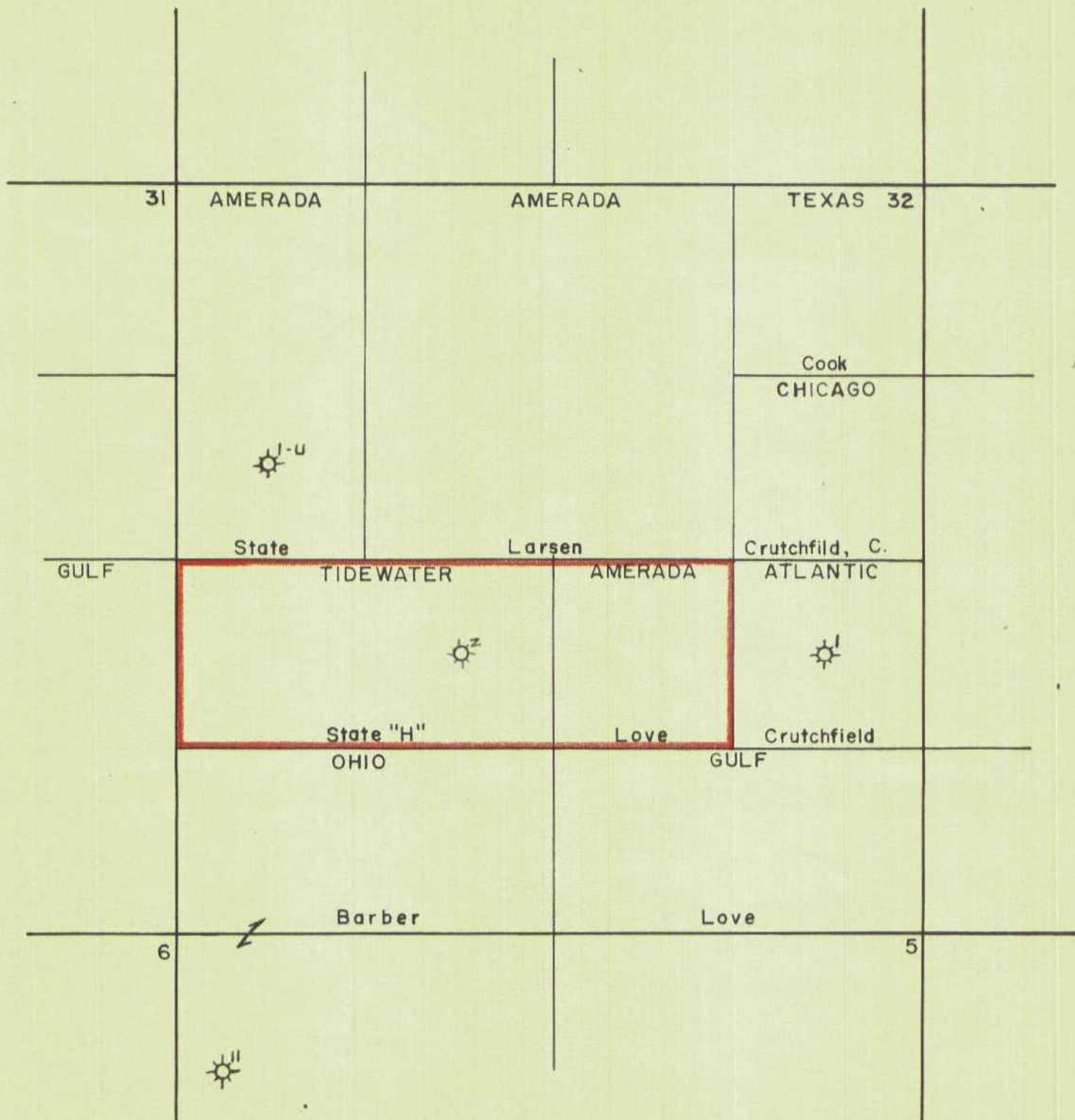
