Gentlemen:

Sinclair Oil & Gas Company makes this application for an Administrative Order under Order R=520 which will establish a 160 acre Nonstandard Gas Proration Unit in the Jalmat Gas Pool to be assigned to Sinclair's Federal 714 Well No. 3.

In this connection Sinclair wishes to state:

- 1. Sinclair is the operator of the Federal 714 Well No. 3 which is located in the NW SW of Section 17-235-36E, Lea County, New Mexico. This well was completed September 19, 1957, from the perforated interval 3548-67 feet and 3588-606 feet in the Yates Sand Formation.
- 2. The proposed 160 acre nonstandard unit consists of Sinclair's Federal 714 Lease that occupies the SW/4 of said Section 17. Sinclair's Federal 714 Well No. 3 is located 990 feet from the West line and 1980 feet from the South line of this proposed unit thus qualifying for a 160 acre administrative assignment.
- 3. The length or width of the proposed unit does no exceed 5280 feet.
- 4. The proposed unit consists of contiguous quarter-quarter sections and lies wholly within a single governmental section.
- 5. The entire proposed unit may reasonably be presumed to be productive of gas from the Jalmat Gas Pool.
- 6. The leasehold interests and the royalty interest are common under this proposed unit.
- 7. All offset operators as defined in Order R-520 have been notified of this application by copy thereof via registered mail. Said operators are listed below.

Sinclair believes that the granting of this application is in the interest of conservation and the protection of correlative rights. Sinclair, therefore, requests that an Administrative Order be issued for the purpose of granting this application.


