- That the Daniel Vaughn B-3 #1 well is located 1980 feet from the West Line and 1980 feet from the North Line of the said Section 3. That the subject well originally produced oil from the Seven Rivers zone, but has recently been plugged back and recompleted in the Yates Sand zone as a dry gas well with an open Flow Potential of 2,650 MCFPD.
