Gentlemen:

The writer respectfully requests that the Conservation Commission grant an exception to the Commission order number R-520 for the subject acreage. The following information is submitted in support of this application:


- 1.) Blankenship Oil Company No. 2 Pech-State, located 1980' from the west line and 1880' from the south line of the subject section is the well from which it is proposed to produce the gas allowable for the requested unit.
- 2.) An Application For Dual Completion, 7-3-58, accompanies this application. Blankenship No. 2 Pech-State is proposed in that application as a dual producer of oil in the South Eunice Field (lower 100' of the Seven Rivers and the Queen Formations) and of gas in the Jalmat Gas Field from perforations in that portion of the Seven Rivers Formation more than 100' above the top of the Queen Formation.
- 3.) A non-standard gas proration unit of 80 acres comprising the N/2 of the SW/4 of Section 32, T-21-S, R-36-E, is requested.
- 4.) The above described gas proration unit consists of contiguous quarter quarter sections (contiguous 40 acre tracts).

- 5.) The above described gas proration unit lies wholly within a single governmental section.
- 6.) The entire proposed gas proration unit may be reasonably presumed to be productive of gas.
- 7.) Neither the length nor the width of the proposed gas proration unit exceeds 5280'.



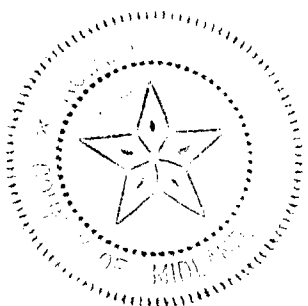
