Reference is made to your application of December 4, 1989 for a non-standard gas well location for your Wood "A" State Well No. 3 located 2310 feet from the North line and 1650 feet from the West line (Unit F) of Section 16, Township 20 South, Range 37 East, NMPM, Eumont Gas Pool, Lea County, New Mexico, which is presently shut-in in the Monument-Tubb zone.

Said well to be dedicated to the previously approved non-standard 80-acre gas spacing and proration unit comprising the E/2 NW/4 of said Section 16 (Division Administrative Order NSP-476, dated March 18, 1959).
