Reference is made to your application for approval of a 40 acre non standard gas proration unit in the Blinebry Gas Pool consisting of the following acreage:

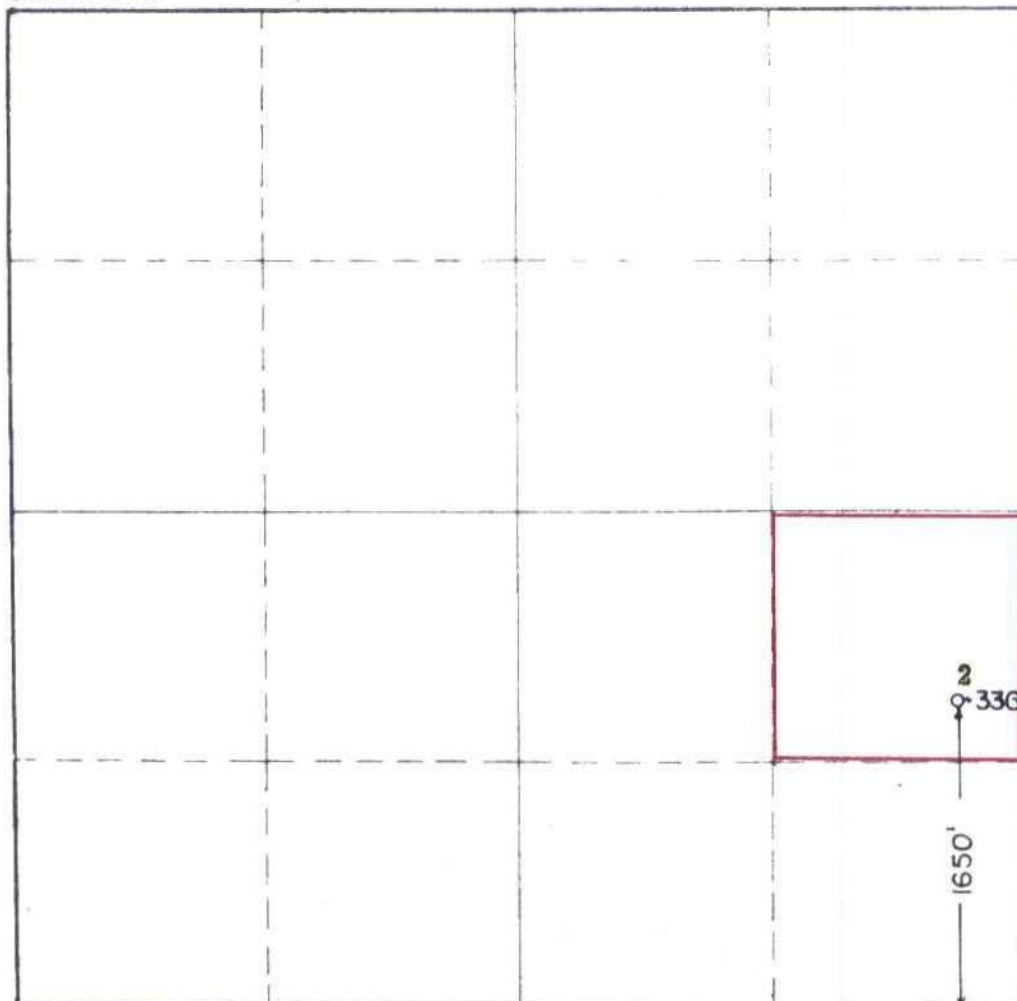
