Gentlemen:

It is respectfully requested that the Conservation Commission approve this application for a 160 acre non-standard gas proration unit embracing the SE/4 of Section 24, T22S, R35E, Lea County, New Mexico and assigned to the Amerada State No. 1.

It is also requested that you please cancel N.S.P. Order, R-762, which was previously assigned to this well and covered 320 acres comprising the SE/4 of Section 24 and the NE/4 of Section 25-22S-35E.

In support of this application, we wish to state the following:

1. The Amerada State No. 1, located 660' FEL and 1980' FSL of Section 24-22S-35E, has been completed as a gas well from within the vertical limits of the Jalmat Gas Pool.
2. This proposed non-standard gas proration unit consists of a quarter section within a single governmental section and the entire unit may reasonably be presumed to be productive of gas.
3. All operators owning interest within 1500' of the Amerada State #1 have been furnished copies of this application by registered mail.






