Application for 80 Acre Non-Standard Gas Proration Units, Blinebry and Tubb Gas Pools, Comprising the N/2 SW/4 of Section 29, T-22-S, R-38-E, Lea County, New Mexico

Gentlemen:

Gulf Oil Corporation hereby makes application for approval of 80 acre Blinebry and <u>Tubb non-standard</u> gas proration units covering the N/2 SW/4 of Section 29, T-22-S, R-38-E, Lea County, New Mexico, and in support thereof states the following facts:

- 1. Applicant is the owner and operator of an oil and gas lease known as its Evelyn Lineberry Lease located in the N/2 SW/4 of Section 29, T-22-S, R-38-E, Lea County, New Mexico.
- 2. Applicant proposes that the N/2 SW/4 of Section 29, T-22-S, R-38-E, Lea County, New Mexico, be established as 80 acre non-standard gas proration units in exception to Rule 5 (A) of Order R-610 and Rule 5 (a) of Order R-586, Blinebry and Tubb Gas Pools, respectively.
- 3. Applicant is owner and operator of the Evelyn Lineberry Well No. 1 located 1,980 feet from the south and west lines of Section 29, T-22-S, R-38-E, Lea County, New Mexico. Applicant proposes to recomplete this well as a gas-gas dual in the Blinebry and Tubb Gas Pools and this well will be used as the unit well.
- 4. The proposed non-standard gas proration units will meet the requirements of Rule 5 (B) of the Oil Conservation Commission Order R-610 for the Blinebry Gas Pool and Rule 5 (d) of the Oil Conservation Commission Order R-586 for the Tubb Gas Pool as follows:

- (a) Contiguous quarter-quarter sections will comprise the units.
- (b) The proposed units lie wholly within a single governmental section.
- (c) All acreage within the proposed units may reasonably be presumed productive of gas.
- (d) The length or width of the proposed units does not exceed 2,640 feet.
- (e) By copy of this letter of application, all operators owning interest in the quarter section in which the proposed units are located and all operators within 1,500 feet of the proposed unit well are notified by registered mail of the intent of Gulf Oil Corporation to form the proposed nonstandard gas proration units. (See attached addressee list.)

In view of the existence of the facts herein stated and compliance with the provisions of Rule 5 (B) of the Oil Conservation Commission Order No. R-610 for the Blinebry Gas Pool and Rule 5 (d) of the Oil Conservation Commission Order R-586 for the Tubb Gas Pool, Gulf Oil Corporation requests that the Secretary of the Commission approve the above described non-standard gas provation units.


