Gentlemen:

Cities Service Oil Company requests administrative approval of a non-standard gas proration unit of 120 acres consisting of the SW, NE, and NW of the SW/A Sec. 2, T-20S, R-37E Eumont Gas Pool, Lea County New Mexico, to be assigned to the State AR #1.

The Cities Service Oil Company State AR #1 located 1980 from the south and west lines of Section 2, when tested May 17, 1960, produced two barrels of oil and 1680 MCF gas in 24 hours for a resulting gas-oil ratio of 840,000/1. The New Mexico Oil Conservation Commission, Hobbs office, on August 12, 1960, advised by letter that the State AR #1 would be classified as a gas well and the oil allowable cancelled effective September 1, 1960.

The State AR #1 meets all requirements of Order No. R-1670 and the non-standard gas proration unit may be reasonably presumed to be productive of gas. A plat is attached hereto showing the location of the State AR #1 and the proposed non-standard proration unit as outlined in red.
