Dear Sir:

Olsen Oils, Incorporated requests approval of a non-standard gas proration unit of 320 acres consisting of the SE/4 and the NE/4 of Section 30, T 25S, R 37E, Lea County, New Mexico, on which is located the Winningham #3.

Olsen Oils, Incorporated warrants that the non-standard gas proration unit consists of contiguous quarter-quarter sections lying wholly within a single governmental section and further warrants that the non-standard gas proration unit is productive of gas and that the length or width of the non-standard gas proration unit does not exceed 5280 feet.

The above unit adds the W/2 NE/4, Section 30, T 25S, R 37E, Lea County, New Mexico formerly dedicated to the Olsen Oils, Inc. Winningham #1 well by number NSP-50 dated December 20, 1954. This change is requested due to the fact that Winningham #1 will not make the present gas allowable assigned to it and further rework is not deemed economical.

By copy of this letter all offset operators within Section 30, T 25S, R 37E and within 1500 feet of subject well are notified of the company's request for a non-standard gas proration unit.

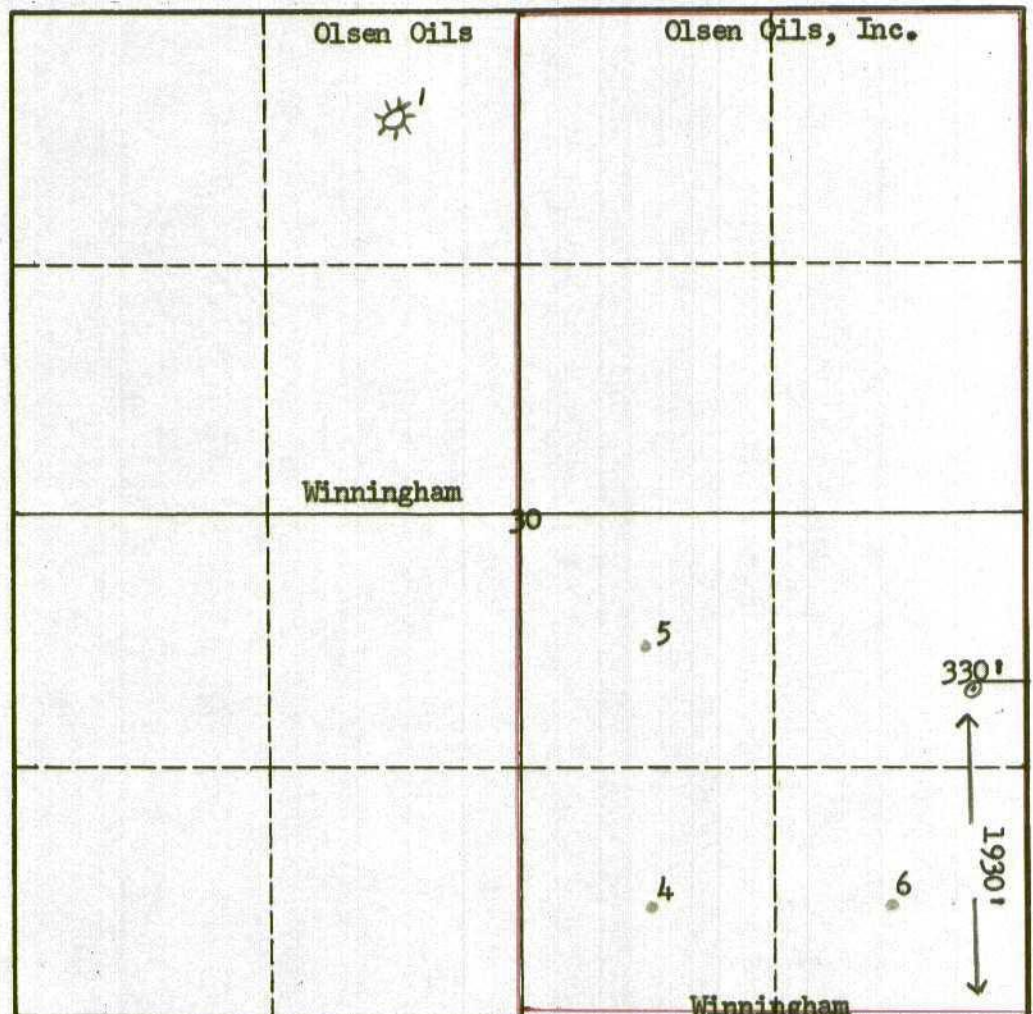
