Re: Application of Gulf Oil Corporation  
for the Approval of a Non-Standard  
80-Acre Gas Proration Unit, Blinebry  
Gas Pool, Lea County, New Mexico

Gentlemen:

In compliance with Rule 30, Order No. R-1670, which prohibits the simultaneous dedication of acreage to an oil and to a gas well, Gulf Oil Corporation respectfully requests exception to Rule 5A of Order No. R-1670 for the approval of a non-standard 80-acre Blinebry Gas Proration Unit covering the S/2 NE/4 of Section 32, Township 22 South, Range 38 East, Lea County, New Mexico.

In support of this application, the following facts are submitted:

1. Gulf's T. R. Andrews Well No. 2, located 1980 feet from the east and north lines of Section 32, Township 22 South, Range 38 East, is completed in the Blinebry Gas Pool and has been assigned, by Administrative Order NSP-551, a non-standard 120-acre gas proration unit covering the E/2 NE/4 and the SW/4 NE/4 of this Section 32.
2. Gulf's T. R. Andrews Well No. 5, located 560 feet from the north line and 660 feet from the east line of Section 32, has been dually completed as an oil well in the Blinebry Pool.
3. ✓ The proposed non-standard gas proration unit consists of contiguous quarter-quarter sections and lies wholly within a single governmental quarter section.
4. ✓ The entire non-standard gas proration unit is reasonably presumed to be gas productive in the Blinebry Gas Pool.
5. ✓ The length or width does not exceed 2640 feet.

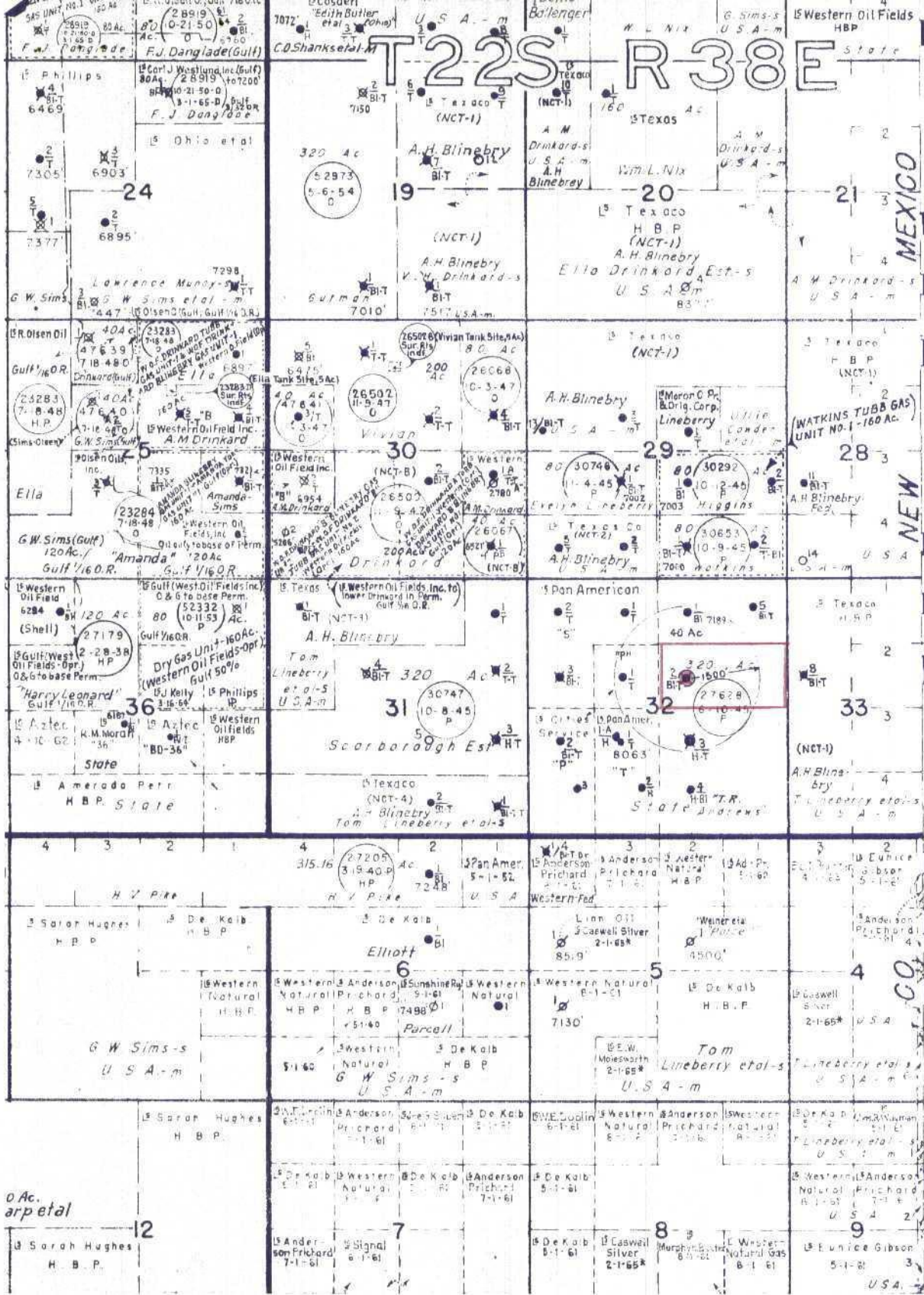
