Dear Mr. Bohling:

Reference is made to your application dated October 22, 1992, for an unorthodox Eumont gas well location in an existing non-standard 320-acre gas spacing and proration unit (GPU) for said Eumont Gas Pool comprising the N/2 of Section 33, Township 21 South, Range 36 East, NMPM, Lea County, New Mexico. Said GPU was authorized by Division Administrative Order NSP-607, dated July 3, 1962 and had dedicated thereon the Arnott-Ramsey (NCT-D) Well No. 3 located in Unit F of said Section 33.

By letter from the Division dated January 16, 1979, the Arnott-Ramsey (NCT-D) Well No. 15, drilled at a standard gas well location in Unit B of said Section 33, was simultaneously dedicated to said GPU.

It is my understanding that the subject well in this matter is currently a shut-in Eumont oil well and upon issuance of this order will be recompleted from the lower oil producing Queen zone to the Yates formation which should encounter gas.

By authority granted me under the provisions of Rule 2(c) of the Special Rules and Regulations for the Eumont Gas Pool, as promulgated by Division Order No. R-8170, as amended, the following described well located at an unorthodox gas well location is hereby approved:

Arnott-Ramsey (NCT-D) Well No. 14 1980' FNL - 660' FEL (Unit H) Also, you are hereby authorized to simultaneously dedicate Eumont Gas production from the Arnott-Ramsey (NCT-D) Well No. 14 with the Arnott-Ramsey (NCT-D) Well Nos. 3 and 15. Furthermore, you are hereby permitted to produce the allowable assigned the subject GPU from all of the said wells in any proportion.

Dear Mr. Saenz:

Reference is made to your application dated April 28, 1998. Chevron U.S.A. Production Company ("Chevron") is hereby authorized to simultaneously dedicate Eumont Gas Pool production to the previously approved non-standard 320-acre gas spacing and proration unit ("GPU") comprising the N/2 of Section 33, Township 21 South, Range 36 East, NMPM, Lea County, New Mexico (approved by Division Administrative Order NSP-607, dated July 3, 1962) from the following three wells:

- the existing Arnott-Ramsay (NCT-D) Well No. 3 (API No. 30-025-04884) located at a standard gas well location 1980 feet from the North and West lines (Unit F) of Section 33;
- the recently recompleted Arnott-Ramsay (NCT-D) Well No. 5 (API No. 30-025-04886) located at a standard gas well location 1980 feet from the North and East lines (Unit G) of Section 33; and,
- the existing Arnott-Ramsay (NCT-D) Well No. 15 (API No. 30-025-26167) located at a standard gas well location 810 feet from the North line and 1980 feet from the East line (Unit B) of Section 33.

Also, Chevron is permitted to produce the allowable assigned said non-standard 320-acre GPU from all three wells in any proportion.

Further, the previously approved Division Administrative Order NSL-3193(SD), dated November 17, 1992, which approved Chevron's Arnott-Ramsay (NCT-D) Well No. 14 (API No. 30-025-04895), located 1980 feet from the North line and 660 feet from the East line (Unit H) of Section 33 as an unorthodox gas well location in the Eumont Gas Pool within the subject 320-acre GPU, and the simultaneous dedication of Eumont gas production from the Arnott-Ramsay (NCT-D) Well Nos. 3, 14, and 15 to the subject 320-acre GPU, shall be placed in abeyance until further notice.
