We forward herewith application in triplicate for approval of a 40-acre gas proration unit for our Hawk B-3 well No. 12 (formerly designated Hawk B-3 No. 3). The proposed unit, consisting of NW/4 SE/4, Section 3, Township 21 South, Range 37 East, is a part of the 160-acre NSP unit consisting of Lot 15, N/2 SE/4 and SE/4 SE/4 of Section 3 authorized by Order No. R-994.


Our Hawk B-3 No. 13 in Unit X was recently recompleted as a Blinebry oil well necessitating the deletion of SE/4 SE/4 from the above described unit. It is our present intention to recomplete wells located in Units O and Q for Blinebry oil production in the near future. Rather than burden you with the administrative load of successive applications for progressively smaller units we are filing this application for the ultimate unit.

If it is satisfactory to you we should appreciate your decreasing the unit size progressively as the Blinebry oil development proceeds, so that the unit well may enjoy the maximum allowable commensurate with the pool rule.

Gentlemen:

Continental Oil Company respectfully requests administrative approval under the provisions of Rule 5C of the Special Rules and Regulations for the Blinebry Gas Pool of Order No. R-1670 for the formation of a 40-acre non-standard gas proration unit consisting of the NW/4 SE/4 of Section 3, Township 21 South, Range 37 East, for its Hawk B-3 No. 12 well located 1980 feet from the South line and 1980 feet from the East line of Section 3, Township 21 South, Range 37 East, Lea County, New Mexico, in the Blinebry Gas Pool.

In support of this request we should like to point out that the proposed unit conforms with the requirements of said Rule 5C in all respects as follows:

1. Said proposed non-standard gas proration unit consists of a single quarter-quarter section.
2. Said proposed non-standard gas proration unit lies wholly within a single governmental quarter section.
3. The entire proposed non-standard gas proration unit may be reasonably presumed to be productive of gas.
4. The length or width of said unit does not exceed 2,640 feet.
5. Copies of this application have been furnished this date

by registered mail to all operators within the same quarter section or within 1,500 feet of said well, as required by the provisions of said Rule 5C.

A plat is attached hereto showing to the best of our knowledge and belief the proposed unit, the location of the No. 12 well and other wells on the lease, offset wells and ownership thereof.

The granting of this application is in the interest of preventing waste and the protection of correlative rights.

In view of the facts set out herein it is respectfully requested that the Commission enter an order approving the non-standard gas proration unit for Continental Oil Company's Hawk B-3 No. 12 well as described above.

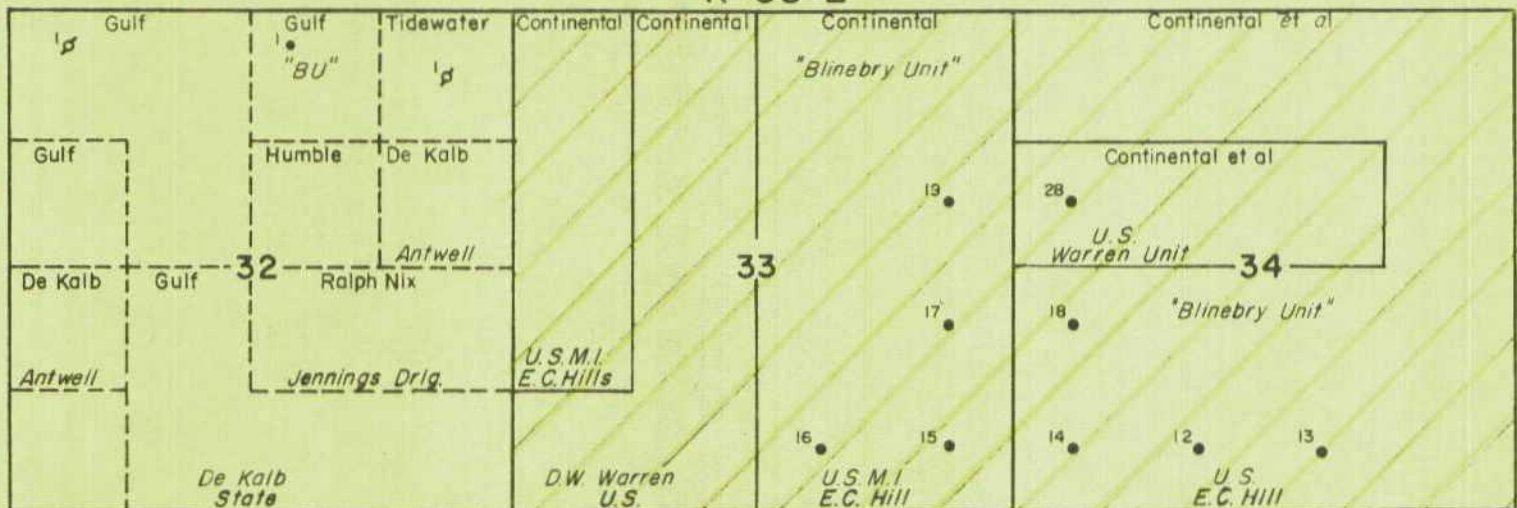
