Gentlemen:

Reference is made to your application for approval of a 160-acre non-standard gas proration unit in the Jalmat Gas Pool consisting of the following acreage:

LEA COUNTY, NEW MEXICO
TOWNSHIP 23 SOUTH, RANGE 37 EAST, NMPM
Section 16: NE/4

It is understood that this unit is to be dedicated to your State JCT Well No. 2, located in Unit G of said Section 16.

By authority granted me under the provisions of Order No. R-1670, as amended, governing the Jalmat Gas Pool, you are hereby authorized to operate the above-described acreage as a non-standard gas proration unit, with allowable to be assigned thereto in accordance with the pool rules, based upon the unit size of 160 acres.

This approval will not be effective until your State JCT Well No. 1 located in Unit B of said Section 16 has been disconnected from the pipeline and a Disconnection Notice has been filed with the District Supervisor, District No. 1, Oil Conservation Commission, Hobbs, New Mexico.
