Re: Application of Amerada Petroleum Corporation for administrative approval of a 160 acre non standard gas proration unit in the Jalmat Pool to be assigned to its State JCT No. 2 located in Unit C, Sec. 16-T23S-R37E, Lea County, New Mexico.


Gentlemen:

Applicant, Amerada Petroleum Corporation states that:

- 1) Applicant is the owner and operator of the 160 acre State JCT lease described as the NE/4 Sec. 16-T23S-R37E, Lea County, New Mexico.
- 2) Subject lease currently has two gas wells completed in the Jalmat Pool. Well No. 1 is located in Unit B with 80 acres described as N/2 of NE/4 Sec. 16 dedicated. Well No. 2 is located in Unit C with 80 acres consisting of the S/2 of NE/4 dedicated.
- 3) Well No. 1 currently produces substantial water and is difficult to keep on production. It is requested that administrative approval be given to shut in Well No. 1 and that the entire 160 acre JCT Lease be dedicated to Well No. 2.
- 4) Proposed 160 acre unit is a standard quarter section and lies wholly within section 16.
- 5) The entire non standard gas proration unit may reasonably be presumed to be productive of gas from the Jalmat Pool. This is apparent from the attached plat showing well locations in the area.
- 6) All operators owning interests outside the non standard unit within section 16 have been furnished a copy of this application by registered mail. Operators owning interests within 1500' of Well No. 2 are included in this group.

Applicant requests that, after the required 30 day waiting period, administrative approval be given the above described matter.

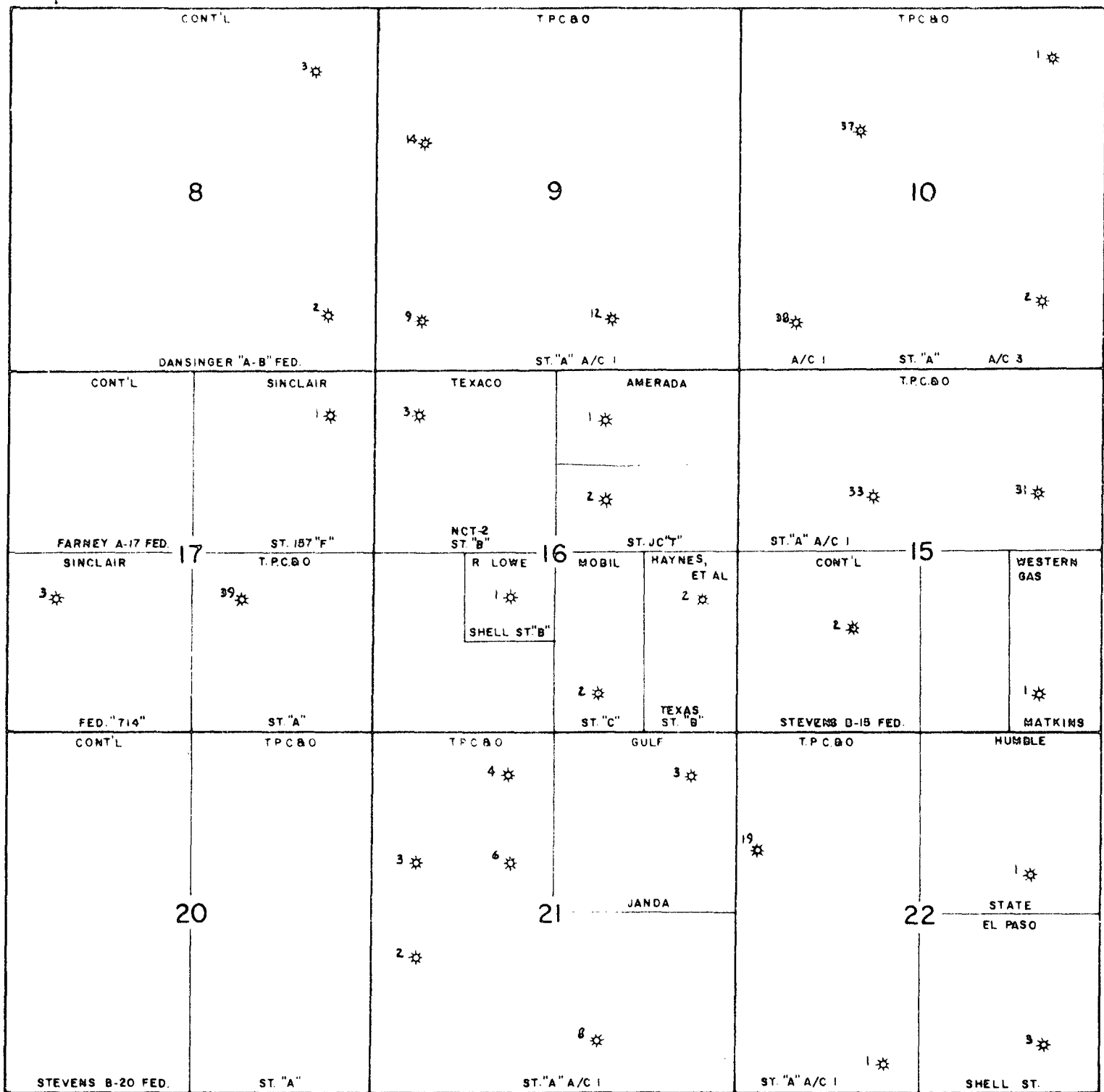
