Dear Sir:

Under the provisions of Commission Order No. R-520, Rule 5 (b) Special Rules and Regulations for the Jalmat Gas Pool, delegating the Secretary of the Commission authority to grant exceptions to the requirements of Rule 5 (a) without notice and hearing for a non-standard gas proration unit, Bogle Oil Company hereby applies for an exception to the rule for the Arnett-Ramsay No. 1.

In support of the application we present the following:

1. Application in triplicate with plat showing the proposed unit of 160 contiguous acres, consisting of the S/2 of the S/2 of Section 2, Township 25 South, Range 36 East, NMPM, Lea County, New Mexico. Offset owner-ships and the unit well, located 660 feet from the south line and 660 feet from the east line of said Section 2 are shown.
2. The entire proposed non-standard gas proration unit may reasonably be presumed to be gas productive, lies wholly within a single governmental section. Neither the length or width of the proposed unit exceeds 5280 feet.
3. By copy of this application all owners having interest in the section in which the proposed unit is situated and which acreage is not included in the unit, and all operators having interest within 1500 feet of the unit well have been notified by registered mail.



4. Subject well was completed February 17, 1960 in the Yates formation from perforations at 3006 to 3016. The calculated absolute potential is 1700 MCF. Construction of a pipeline to El Paso Natural Gas Company system will be started at an early date.

5. Form C-103 has been filed showing change of operator from E. P. Campbell to Bogle Oil Company.
