Gentlemen:

Continental Oil Company respectfully requests administrative approval under the provisions of Rule 5 (C) of the Special Rules and Regulations for the Jalmat Gas Pool of Order R-1670 for the formation of a 120-acre non-standard gas proration unit consisting of the NE/4 SE/4 and S/2 SE/4 of Section 29, Township 23 South, Range 37 East, for its Stewart 29 No. 2 well located 2310 feet from the south line and 990 feet from the east line of Section 29, Township 23 South, Range 37 East, Lea County, New Mexico, in the Jalmat Gas Pool.

In support of this request we should like to point out that the proposed unit conforms with the requirements of said Rule 5(C) in all respects as follows:

1. Said proposed non-standard gas proration unit consists of contiguous quarter-quarter sections.
2. Said proposed non-standard gas proration unit lies wholly within a single governmental section.
3. The entire proposed non-standard gas proration unit may be reasonably presumed to be productive of gas.
4. The length or width of said unit does not exceed 5,280 feet.
5. Copies of this application have been furnished this date by registered mail to all operators in said Section 29 and all operators within 1,500 feet of said well, as required by the provisions of said Rule 5 (C).

A plat is attached hereto showing to the best of our knowledge and belief the proposed unit, the location of the No. 2 well and other wells on the lease, offset wells and ownership thereof.

A granting of this application is in the interest of preventing waste and the protection of correlative rights.

In view of the facts set out herein, it is respectfully requested that the Commission enter an order approving the non-standard gas proration unit for Continental Oil Company's Stewart 29 No. 2 well as described above.

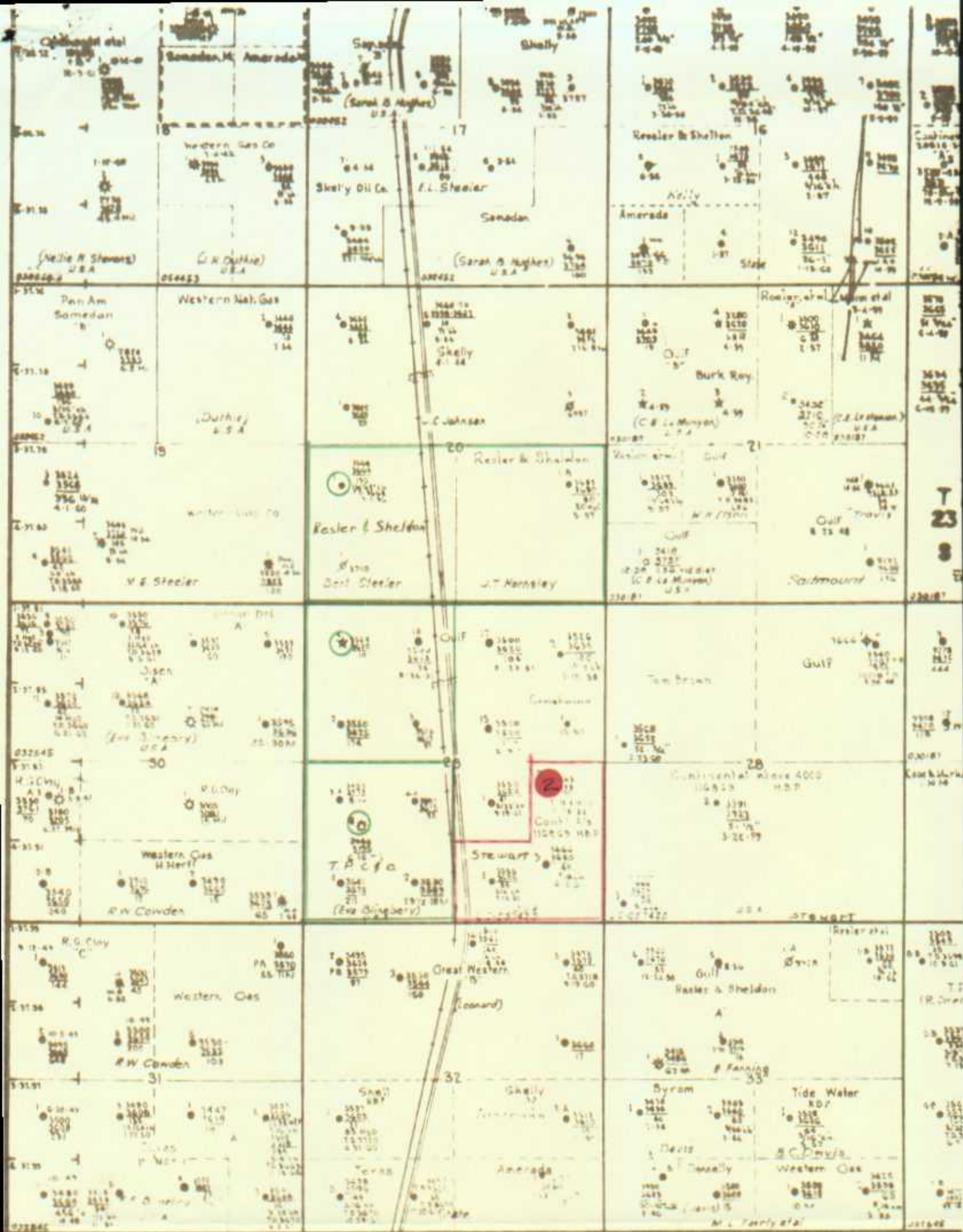
