Gentlemen:

Re: Continental Oil Company application for a 240-acre non-standard gas proration unit and a non-standard location for its Farney A-5 No. 2 in Section 5, T-23, R-36, NMPM, Jalmat Pool, Lea County, New Mexico

Continental Oil Company respectfully requests administrative approval under the provisions of Rules 3 and 5-C of the Special Rules and Regulations for the Jalmat Gas Pool of Order R-1670 for a non-standard location and the formation of a 240-acre non-standard gas proration unit consisting of the SE/4 and E/2 of SW/4, Section 5, Township 23 South, Range 36 East, for its Farney A-5 No. 2 well located 660 feet from the east line and 1980 feet from the south line of Section 5, Township 23 South, Range 36 East, Lea County, New Mexico, in the Jalmat Gas Pool.

In support of this request, we should like to point out that the well was originally completed July 22, 1937, as an oil well and subsequently recompleted for Jalmat gas production. Furthermore, the proposed unit conforms with the requirements of said Rule 5-C in all respects as follows:

1. Said proposed non-standard gas proration unit consists of contiguous quarter-quarter sections.
2. Said proposed non-standard gas proration unit lies wholly within a single governmental section.
3. The entire proposed non-standard gas proration unit may be reasonably presumed to be productive of gas.
4. The length or width of said unit does not exceed 5,280 feet.
5. Copies of this application have been furnished this date by registered mail to all operators in the same section and those within 1980 feet of said well, as required by the provisions of said Rules 3 and 5-C.

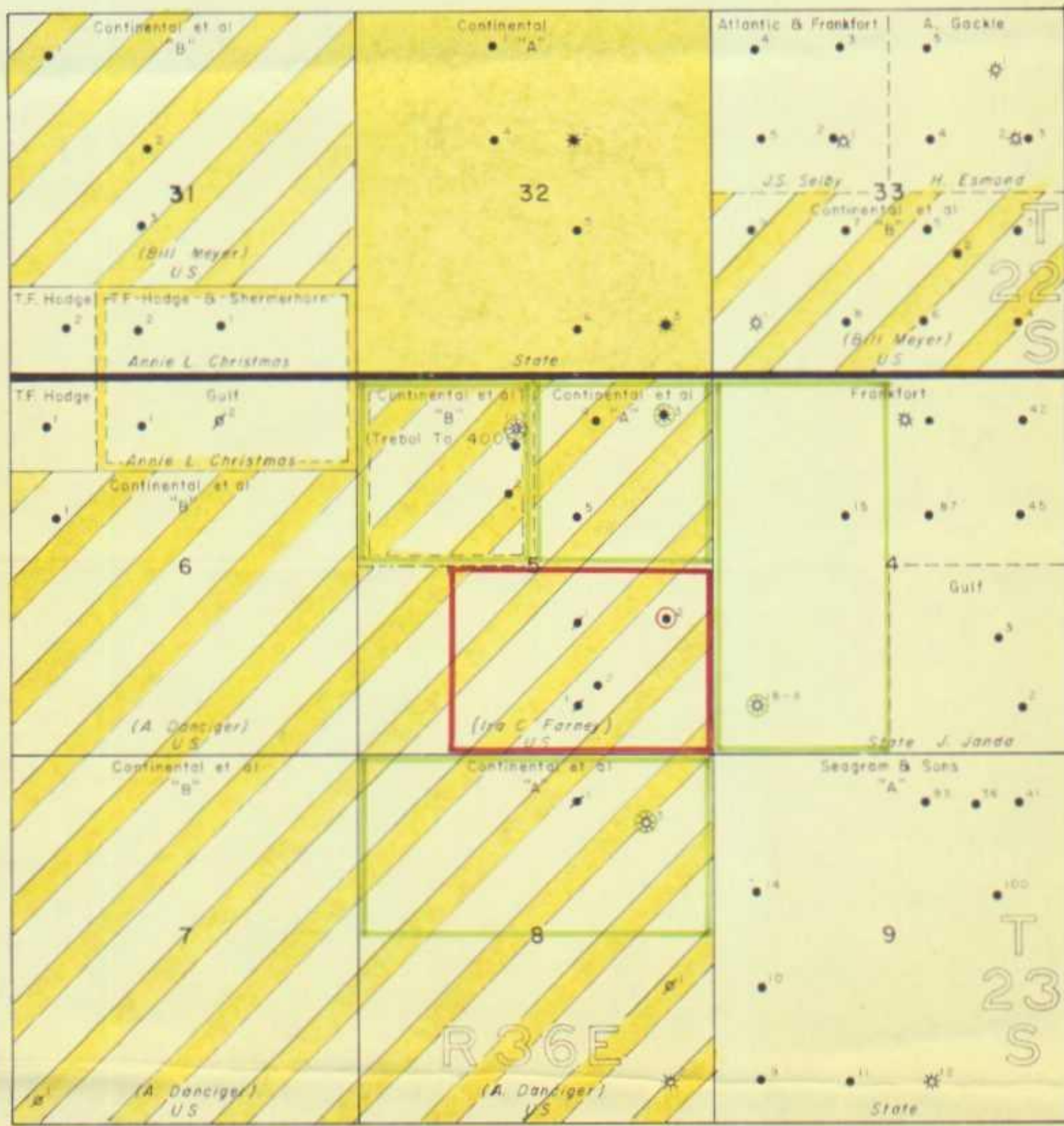
