Re: Application of TEXACO Inc. For Approval of a Non-Standard Gas Proration Unit, Blinebry (Gas) Pool, Lea County, New Mexico

Gentlemen:

TEXACO Inc. hereby makes application for approval of an 80-acre non-standard gas proration unit in the Blinebry (Gas) Pool, comprised of the N/2 of NW/4 of Section 31, T-22-S, R-38-E, Lea County, New Mexico, with the A. H. Blinebry (NCT-3) Well No. 1 being the unit well, and in support thereof states the following:

1. TEXACO Inc. is owner and operator of the A. H. Blinebry (NCT-3) Lease comprising 160 acres, being the N/2 of NW/4, the SW/4 of NW/4, and the NW/4 of the NE/4 of Section 31, T-22-S, R-38-E, Lea County, New Mexico, as shown on the attached plat.

2. TEXACO Inc. is owner and operator of the A. H. Blinebry (NCT-3) Well No. 1 located in Unit D, 660 feet from North line and 660 feet from the West line of Section 31, T-22-S, R-38-E, Lea County, New Mexico. This well was completed on September 16, 1958, as a dual completion producing from the Blinebry (011) Pool and Tubb (Gas) Pool. The Blinebry zone in this well produces liquid hydrocarbons possessing a gravity of 41.2° API; however, the current gas-liquid ratio is in excess of the 32,000 cubic feet per barrel limit for the Blinebry (011) Pool, which requires gas well classification. TEXACO Inc. proposes that the N/2 of NW/4 of Section 31, T-22-S, R-38-E, Lea County, New Mexico, be established as an 80-acre non-standard gas proration unit in the Blinebry (Gas) Pool with A. H. Blinebry (NCT-3) Well No. 1 being the unit well. The remaining acreage of the lease is dedicated to wells producing from the Blinebry (Oil) Pool.

3. The proposed non-standard gas proration unit will meet the requirements of Rule 5 (c) of Order No. R-1670, General Rules and Regulations for Southeastern New Mexico and Special Rules and Regulations, Blinebry (Gas) Pool as follows:

- (1) The proposed non-standard proration unit consists of less acreage than a standard proration unit.
- (2) The non-standard gas proration unit consists of contiguous quarter-quarter section.
- (3) The unit lies wholly within a single governmental quarter section.
- (4) The entire unit may reasonably be presumed to be productive of gas from the Blinebry (Gas) Pool.
- (5) The length or width of the unit does not exceed 2,640 feet.
- (6) By copy of this letter of application, all operators owning interest in the quarter section in which the proposed unit is located and all operators owning interest within 1500 feet of the unit well are notified by registered mail of the intent of TEXACO Inc. to form the proposed non-standard gas proration unit. Offset operators notified are:

Based upon the facts recited above, TEXACO Inc. respectfully request that the New Mexico Oil Conservation Commission approve administratively the non-standard gas proration unit described above.


