It is respectfully requested that the Oil Conservation Commission authorize administratively a non standard gas proration unit covering the S/2 SW and the NW SW of Section 3, 120 acres, to be dedicated to the Brunson B Well #6 located 380' FSL and 330' FWL of Section 3, Township 22S, Range 37E, Blinebry Gas Pool, Lea County, New Mexico.

The Brunson B Well #6 now has a 160 acre allocation but due to the completion of Brunson B Well #2 as a Blinebry Oil well it is requested that 40 acres be assigned to Brunson B Well #2 and the remaining 120 acres of the gas unit be assigned to the Brunson B Well #6.

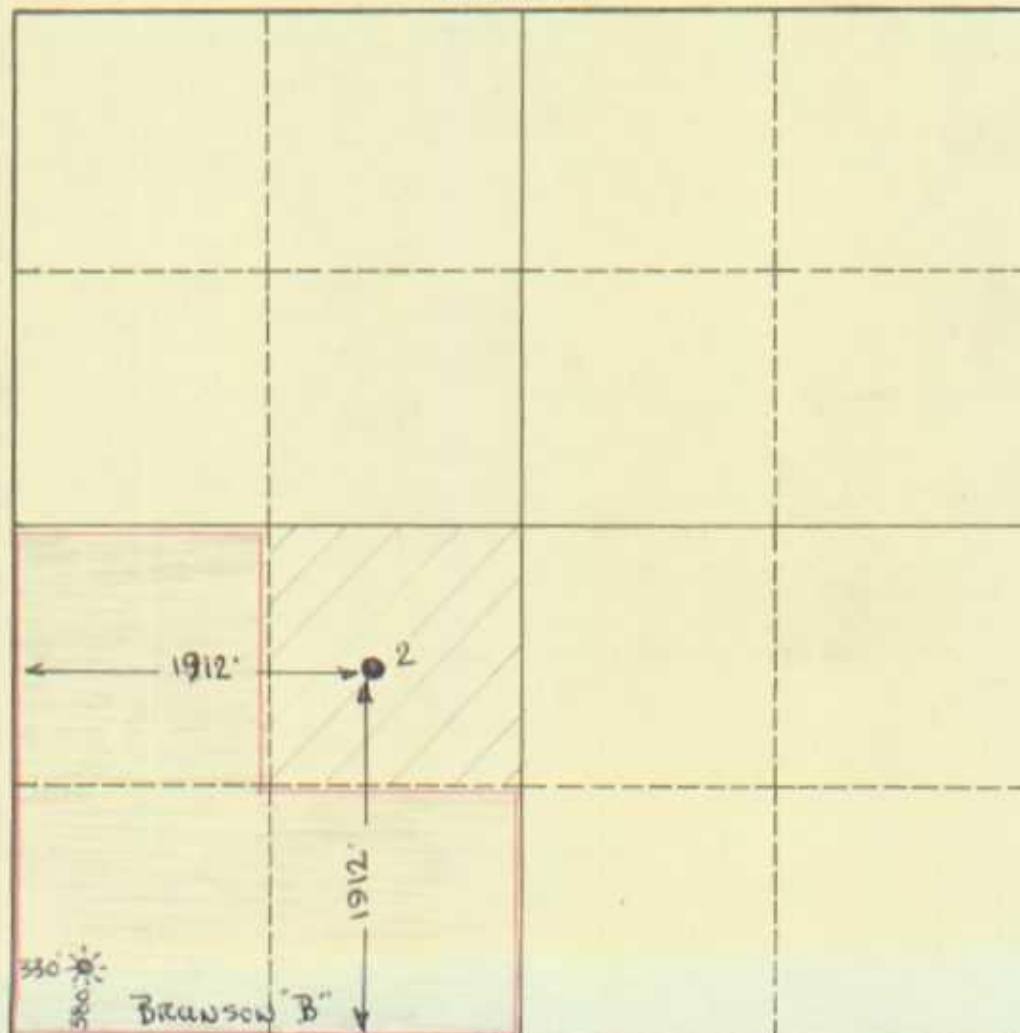
