Dear Sir:

Administrative Order NSP-698, dated February 1, 1965, approved a 160 acre Non-standard Gas Proration Unit in the Jalmat Pool, located in the SW/4 of Section 29, T-24-S, R-37-E, Lea County, New Mexico. This Unit was dedicated to the Wm. H. Harrison "D" WN Well No. 4. It is requested that this order be cancelled and a 320 acre Non-standard Gas Proration Unit, consisting of the following acreage; W/2 of Section 29, T-24-S, R-37-E, be approved and dedicated to the Wm. H. Harrison "D" WN Unit Well No. 1 (formerly the Wm. H. Harrison "D" WN Well No. 4)

In this connection Sinclair wishes to state:

- 1. The Non-standard Proration Unit Sinclair wishes to have assigned to subject well consists of Sinclair's Wm. H. Harrison "D" WN Unit Lease which contains 320 acres and is located in the W/2 of Section 29, T-24-S, R-37-E. The Unit well is located 1980' from the south line and 660' from the west line of the Unit. This well is presently completed as a dual Langlie Mattix oil well and Jalmat gas well.
- 2. The length or width of the proposed Unit does not exceed 5280. The leasehold interests are common, and the royalty interests are unitized.
- 3. All the acreage within the proposed Unit may reasonably be presumed productive of gas. The Unit is shown on the enclosed plat and by copy of this letter of application, all operators owning interest in this section and all operators within 1500° of the proposed Unit are notified by certified mail of the intent of Sinclair to form the proposed non-standard gas proration unit.

Sinclair, therefore, requests administrative approval of the above described non-standard gas proration unit.
