Gentlemen:

TEXACO Inc. respectfully requests administrative approval to form a 160 acre non-standard proration unit in the Justis Gas Pool consisting of the SE/4 of Section 26, T-24-S, R-37-E, to be dedicated to gas production from the C. C. Fristoe (b) NCT-2 Well No. 13, located 990 feet from the South line and 1979 feet from the East line of said Section 26.

In support of this request the following facts are submitted:

1. The proposed non-standard unit consists of less acreage than a standard proration unit of 320 acres.
2. The proposed non-standard proration unit consists of contiguous quarter-quarter sections.
3. The proposed non-standard proration unit lies wholly within a single governmental section.
4. The entire non-standard proration unit may reasonably be presumed to be productive of gas from the Justis Gas (Glorieta) pool.
5. All offset operators, as listed on the attached plat, are being notified by copy of this application by registered mail.

Based upon the facts as recited above, TEXACO Inc. respectfully requests that the New Mexico Oil Conservation Commission approve administratively the non-standard gas proration unit described above.

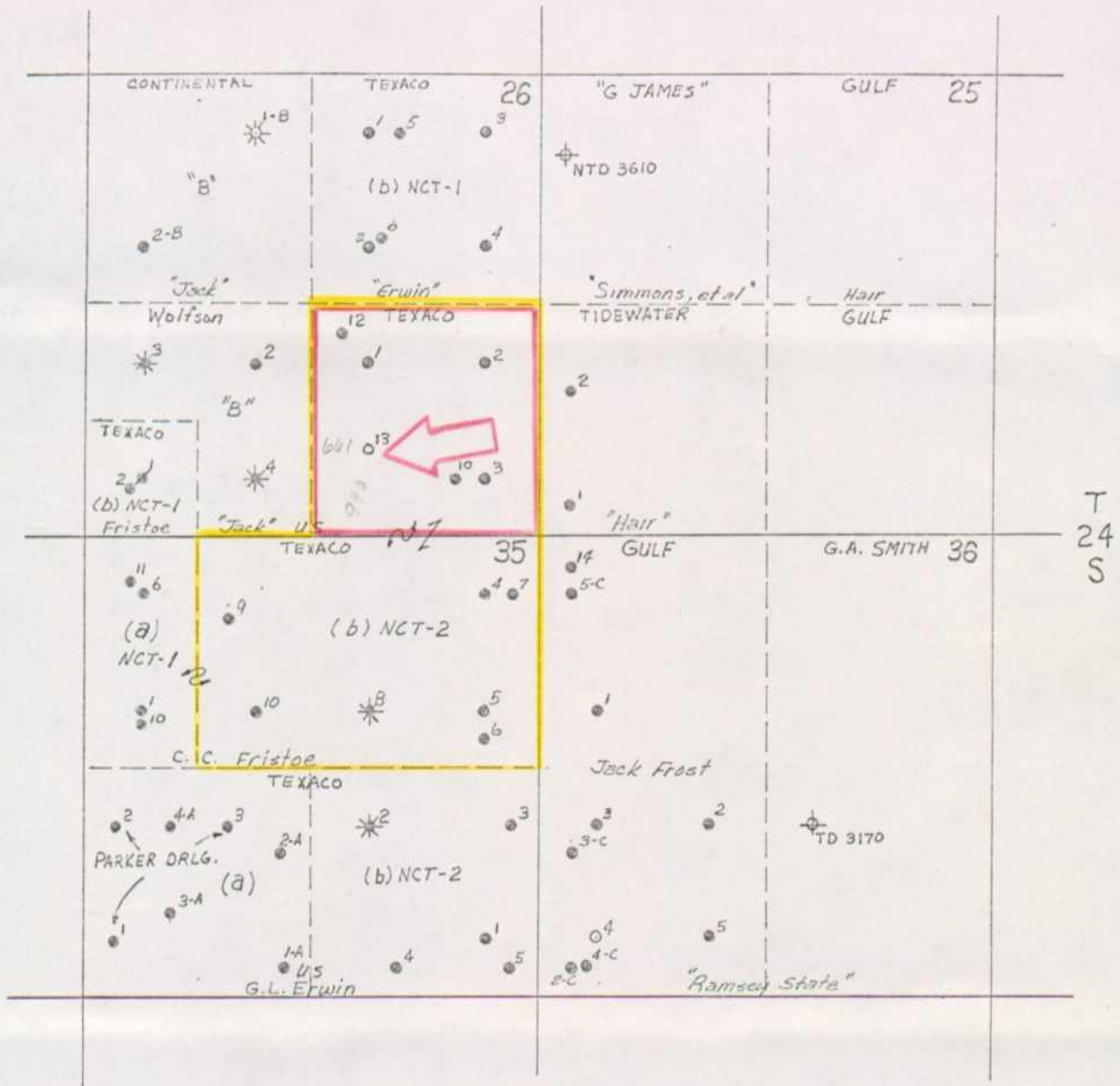
