We respectfully submit this application for and request approval of an 80 acre non-standard gas proration unit in the Blinebry Gas Pool consisting of the following acreage:

LEA COUNTY, NEW MEXICO
TOWNSHIP 21, SOUTH, RANGE 37 EAST
E/2 of the NW/4, Section 16

This unit shall be assigned to our State "C" Tract 12 Well No. 4 located 1980' from the North and 3300' from the East lines and in the SE/4 of the NW/4 (Unit F) of Section 16, T-21-S, R-37-E, NMPM, Lea County, New Mexico.

The re-completion of our State "C" Tract 12 Well No. 3, located in the SW/4 of the NW/4 of Section 16, T-21-S, R-37-E, occasioned this non-standard proration unit.

In support of our request for exception approval without notice and hearing to Rule 5 (A) of Order R-1670, the following is submitted:


2. The non-standard gas proration unit

- (a) Consists of contiguous quarter-quarter sections;
- (b) Lies wholly within a single governmental section;
- (c) May reasonably be presumed to be production of gas;
- (d) Length or width of proration unit does not exceed 2640';
- (e) Lies within the horizontal limits of the Blinebry Gas Pool.

3. By certified mail, copies of this letter are being furnished all offset operators notifying that application is being made for a non-standard proration unit.

4. A plat showing acreage to be dedicated, well location and offset ownership is attached.
