Continental Oil Company Application for a 40-Acre NSP Unit - Lockhart A-27 Well No. 11, Section 27, T-21S, R-37E, Lea County, New Mexico

Continental Oil Company respectfully requests Administrative Approval under the provisions of Rule 5(b) of the Special Rules and Regulations for the Blinebry Gas Pool of Order No. R=1670 for approval of a 40-acre non-standard gas proration unit for its Lockhart A=27 Well No. 11, located 1980' from the north line and 660' from the east line of Section 27, T=21S, R=37E, Lea County, New Mexico in the Blinebry Gas Pool.

The unit is proposed to consist of the SE/4 NE/4 of Section 27, T=21S, R=37E. In support of this request we should like to point out that the proposed unit conforms with the requirements of Rule 5(b) in all respects as follows:

1. Said unit consists of contiguous quarter-quarter sections (and or lots).

2. Said unit lies wholly within a single governmental section.

3. The entire proposed unit may be reasonably presumed to be productive of gas.

4. The length or width of said unit does not exceed 5,280 feet.

5. Copies of this application have been furnished by certified mail to all offset operators and all operators within 1,500 feet of said well.
