Application for 120-Acre NSP Unit - Continental Oil Company - Hawk B-1
No. 2, Unit Letter J, Section 9, T-21S, R-37E, Lea County, New Mexico

Continental Oil Company respectfully requests administrative approval for a 120-acre non-standard gas proration unit for its Hawk B-1 No. 2, located 1980' from the south line and 1980' from the east line of Section 9, T-21S, R-37E, Lea County, New Mexico. Approval is requested under rule R-1670-N of the Special Rules and Regulations for the Blinbry Gas Pool.

The proposed unit is to consist of the E/2 of the SW/4 and the NW/4 of the SE/4 of Section 9, T-21S, R-37E of Lea County, New Mexico. It is requested that this order supercede Administrative Order No. R-4489, as approved on March 16, 1973, for a 160-acre simultaneous dedication NSP Unit for Hawk B-1 wells No. 2 and 4.

The proposed unit conforms to the requirements of Rule 5 (C) in its entirety, as follows:

- (1) Said unit consists of contiguous quarter-quarter sections (and/or lots).
- (2) Said unit lies wholly within a single governmental section.
- (3) The entire proposed unit may be reasonably presumed to be productive of gas.
- (4) The length or width of said unit does not exceed 5,280 feet.
- (5) Copies of this application have been furnished by certified mail to all offset operators and all operators within said section.

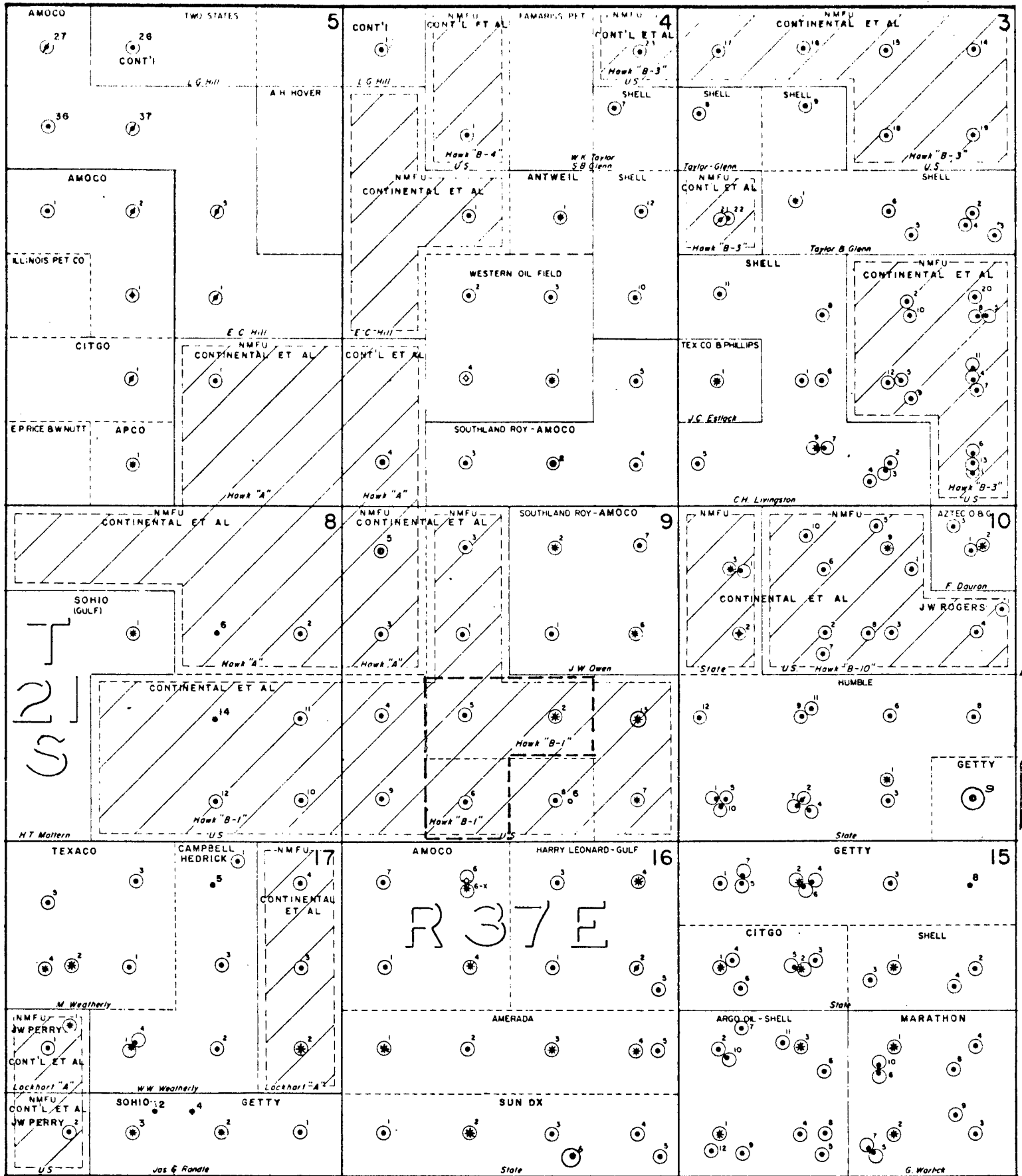
