Dear Mr. Ramey:

Hondo Drilling Company (P. O. Drawer 2516, Midland, Texas 79702) seeks administrative approval of a non-standard gas unit for the proposed subject well, on the basis of a variation in the legal subdivision of the U. S. Public Land Surveys, under the following provision of paragraph D.II. of Rule 104 of New Mexico Oil Conservation Commission Rules and Regulations dated January 1, 1976:

"The Secretary-Director of the Commission may grant administrative approval to non-standard gas units without notice and hearing when an application has been filed for a non-standard unit and the unorthodox size or shape of the unit is necessitated by a variation in the legal subdivision of the U. S. Public Land Surveys . . ."


The proposed wellsite is located at 660' FSL and 1980' FEL of Section 31-T18S-R29E, Eddy County, New Mexico, and is projected to the Morrow formation at a depth of 11,500 feet. The lower half of the section will be dedicated to the proposed well. This half-section consists of a total of only 276.4 acres, rather than the standard of 320 acres, as a result of a variation in the legal subdivision of the U. S. Public Land Surveys in this section.

A lease ownership map of Section 31 and the surrounding area is enclosed, showing the variations in the Public Land Survey which necessitate the dedication of less-than-standard acreage to the proposed well.
