7. No change in gas purchaser is contemplated and by certified copy of this petition, Phillips Petroleum Co. is requested to confirm to Supervisor, District 1, Oil Conservation Division, Energy & Minerals Department, that gas from this well is separately metered.

Campbell & Hedrick request that in the interest of conservation and to protect the correlative rights, the Oil Conservation Division grant administrative approval of this petition.


