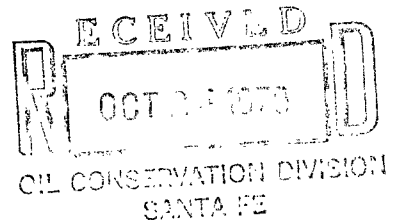

Gentlemen:

We respectfully request administrative approval, subject to the 30-day waiver waiting period, of a 200-acre non-standard proration unit for the captioned well, as an exception to Order No. R-1670, Rule 5(A).

The proposed unit will consist of the NE/4 and NE/4 SW/4, Section 26, T-24-S, R-36-E. Well No. 18 spots 330' FN and 2310' FW Lines of the section and was originally completed in the Jalmat Yates 7-Rivers Oil Pool at an orthodox location and on a standard oil proration unit. The proposed unit is that previously dedicated to Well No. 12 which is to be plugged and abandoned upon successful completion of No. 18 as a gas well. A plat of the proposed unit and location of Well No. 18 is attached.

By certified mail copy, all offset operators are being notified of this request. These waivers of objections are requested to be mailed direct to the Division with a copy to this office. A copy of mailing certifications is attached.
