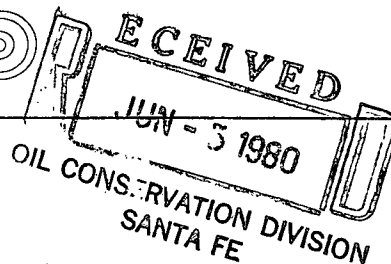

Gentlemen:

Request for NSP Unit - Danciger A-8 Well No. 4, Unit letter H, 2310' FNL and 810' FEL of Section 8, T-235, R-36E, Lea County, New Mexico

Conoco, Inc. respectfully requests administrative approval for a 160 acre non-standard proration unit for the proposed Danciger A-8 No. 4 well in the Jalmat Gas Pool. The proposed NSP unit will consist of the S $\frac{1}{2}$ , NE $\frac{1}{4}$  and the N $\frac{1}{2}$ , SE $\frac{1}{4}$  of Section 8, as shown on the attached plat. This well will effectively drain the recoverable reserves which the Danciger A-8 No. 2 will not be able to produce.

The proposed unit will conform to regulatory standards as follows:

- (1) Said unit consists of contiguous quarter - quarter sections (and/or lots).
- (2) Said unit lies wholly within a single governmental section.
- (3) The entire proposed unit may be reasonably presumed to be productive of gas.
- (4) The length or width of said unit does not exceed 5,280 feet.
- (5) Copies of this application have been furnished by certified mail to all offset operators and all operators within said section.

Administrative approval is requested under R-1670 of the Special Rules and Regulations for the Jalmat Gas Pool.

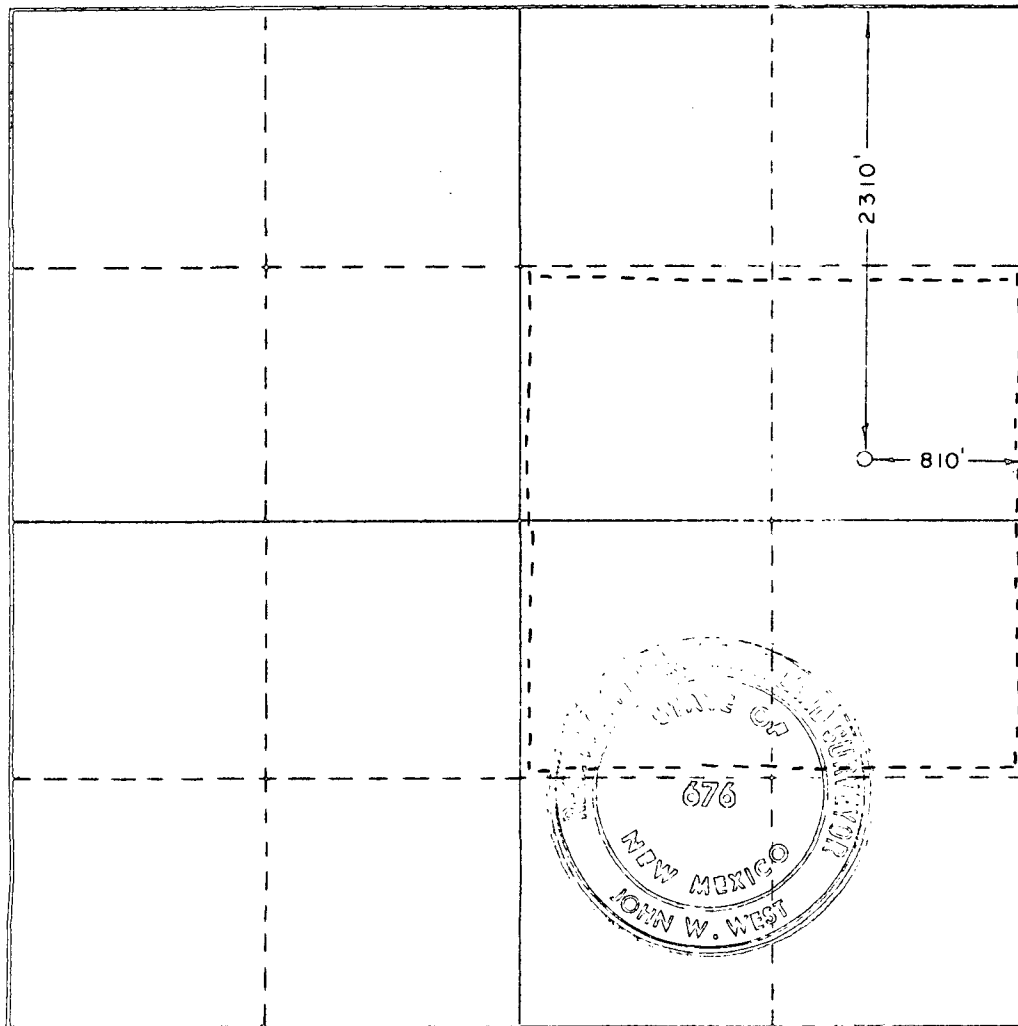
