

ARCO Oil and Gas Company (AOGC) respectfully requests administrative approval for a 40-acre non-standard proration unit for the Lea 396 State No. 2, located SE/4 NW/4, Section 35, T-15-S, R-36-E, Lea County, New Mexico. This application is necessary due to offset development.


