

Exxon requests approval for a nonstandard proration unit for the above captioned well. It is proposed to complete this well in the undesignated Dean Permo-Pennsylvanian Pool. Field Rules for the Dean Permo-Pennsylvanian pool state that each well completed in said pool shall be located on 80-acre proration units embracing two adjacent governmental quarter-quarter sections or lots within a single governmental section.

The above named lease and proposed well are located in Section 6, T16S, R37E, which is an oversized section. The lots committed to Well No. 2 are oversized as well and contain a total of 91.28 acres. For this reason, Exxon is requesting approval for the nonstandard proration unit.

By copy of this letter, we are notifying the offset operators of our application for a nonstandard proration unit.
