Amended Administrative Order NSP-1539

Reference is made to your application of March 13, 1989 to amend Administrative Order NSP-1539 dated August 29, 1988 to include provisions for a non-standard gas spacing and proration unit in the Basin-Fruitland Coal (Gas) Pool.


Under the provisions of Rule 6 of the Special Rules and Regulations for the Basin-Fruitland Coal (Gas) Pool, as promulgated by Division Order No. R-8768, said Administrative Order NSP-1539 is hereby amended and the following described 219.75 acre non-standard gas spacing and proration unit in said pool is hereby approved.

SAN JUAN COUNTY, NEW MEXICO
TOWNSHIP 30 NORTH, RANGE 8 WEST, NMPM
Section 6: Lots 3, 4, 5, 6 and 7, SE/4 NW/4, E/2 SW/4

Said unit is to be dedicated to the Howell "G" Com Well No. 300 to be drilled at an unorthodox coal gas well location (previously authorized pursuant to Decretory Paragraph No. 4 of said Order No. R-8768) 1430 feet from the North line and 1090 feet from the West line (Unit F) of said Section 6.

All other provisions of Administrative Order NSP-1539 shall remain in full force and effect until further notice.


SAN JUAN COUNTY, NEW MEXICO
