
Reference is made to your applications of December 6, 1988 and February 13, 1989 for a 356.26-acre non-standard gas proration unit consisting of the following acreage in the Basin-Fruitland Coal (Gas) Pool:

RIO ARriba COUNTY, NEW MEXICO
TOWNSHIP 31 NORTH, RANGE 5 WEST, NMPM
Section 2: All

It is my understanding that this unit is to be dedicated to your Rosa Unit Well No. 239 to be drilled at an unorthodox coal gas well location 880 feet from the South line and 1205 feet from the East line (Unit P) of said Section 2, hereby approved under provisions of Rule 8 of the Special Rules and Regulations for this pool as promulgated by Division Order No. R-8768.
