Gentlemen:

Chevron U.S.A. Inc. respectfully requests administrative approval for an 80-acre Non-Standard Gas Proration Unit in the Blinebry Oil and Gas Pool, comprising the E/2 of the NE/4, of Section 28, T-21-S, R-37-E, Lea County, New Mexico, to be assigned to Chevron's Eunice King Well No. 13. In support thereof, Chevron U.S.A. Inc. states the following facts:

- 1) As a result of adding perforations in the Blinebry pay it is necessary to reclassify Chevron's Eunice King Well No. 13 from a Blinebry Oil well to a Blinebry Gas well. This well is located 554 feet FNL, and 554 feet FEL of Section 28, T-21-S, R-37-E, Lea County, New Mexico. Due to this reclassification this well's location is unorthodox.

The subject well is dually completed in the Tubb Gas Pool and the Blinebry Oil Pool. The Eunice King Well No. 13 currently has 40-acres in the Blinebry Oil pool dedicated to it. We now desire to re-classify this well as a Blinebry gas well and dedicate 80-acres comprising the E/2 of the NE/4 of Section 28, T-21-S, R-37-E to this well.

- 2) The proposed Non-Standard Gas Proration Unit will meet the requirements for a Non-Standard Gas Proration Unit as follows:
- a. The proposed unit consists of 80-acres that are contiguous.
 - b. The proposed unit lies wholly within a single government section in the Blinebry Gas Pool.
 - c. The entire proposed unit may reasonably be presumed to be productive of gas from the Blinebry Gas Pool.
 - d. A copy of this application will be sent by certified mail to all offset operators and operators owning interests in the proposed unit's boundary and shall serve as notification.

In support of this application, attached is a plat outlining the proposed Non-Standard Gas Proration Unit, and showing all offset properties and wells.

In view of the facts submitted, Chevron U.S.A. Inc. requests that administrative approval of the subject 80-acre Non Standard Gas Proration Unit be granted. We also request approval of the unorthodox gas well location under the provisions of Rule 104. 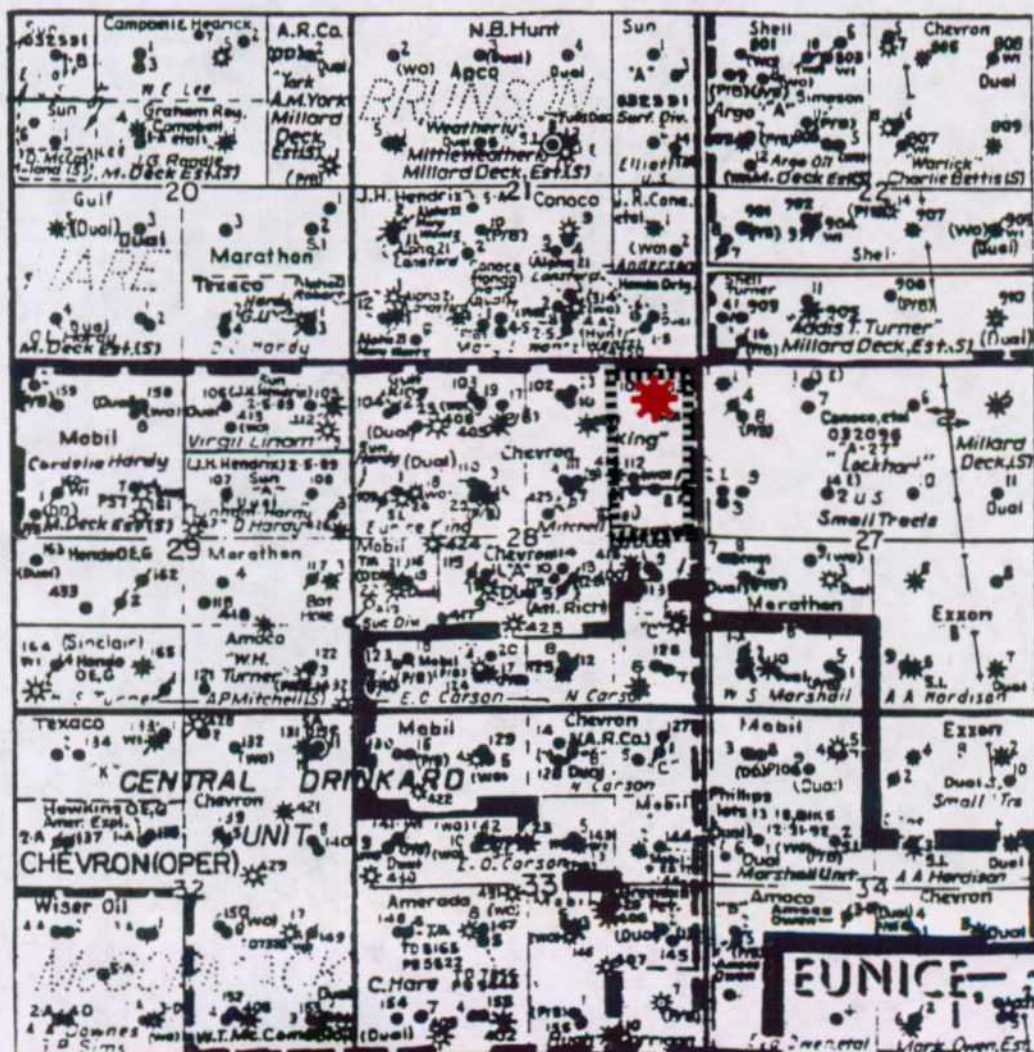

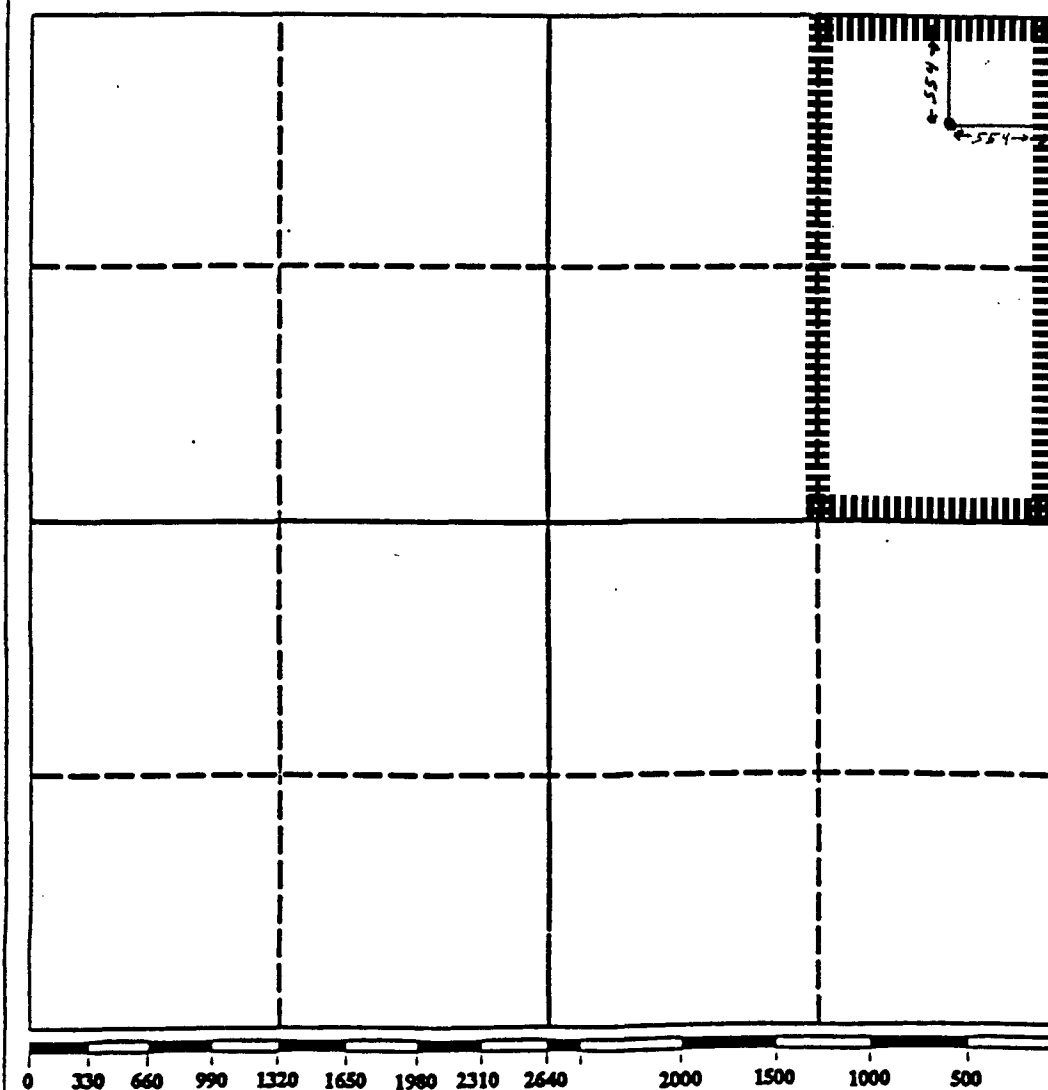
