Chevron U.S.A. Inc. respectfully requests administrative approval for an 40-Acre Non-Standard Gas Proration Unit in the Blinebry Oil and Gas Pool, comprising the NW/4 of the NE/4 of Section 16, T-22-S, R-37-E, Lea County, New Mexico, to be assigned to Chevron's R. E. Cole (NCT-A) Well No. 6-B. In support thereof, Chevron U.S.A. states the following facts:

1) As a result of the scheduled C-116 test on the subject well, it is now necessary to reclassify Chevrons R. E. Cole (NCT-A) Well No. 6-B from a Blinebry Oil well to a Blinebry Gas well. This well is located 554' FNL and 1874' FEL of Section 16, T-22-S, R-37-E, Lea County New Mexico. Due to this wells' reclassification it's location is unorthodox in that it is less than 660' from the outer border.

The subject well is currently completed in the Blinebry Oil and Gas Pool. The R.E. Cole (NCT-A) Well No 6-B currently has 40-acres in the Blinebry Oil pool dedicated to it. We now desire to re-classify this well as a Blinebry gas well and leave the 40-acre dedication as is.




