Gentlemen:

Chevron U.S.A. Inc. respectfully requests your approval of our administrative application for a 160-acre Non-Standard Gas Proration Unit in the Jalmat Tansill Yates Seven Rivers (Pro Gas) Pool comprising the W/2 W/2, Section 32, T-25-S, R-37-E, NMPM, Lea County, New Mexico.

We are also requesting your approval to dedicate this 160-acre proration unit to our Arnott Ramsay (NCT-B) Well No. 1 located 990 feet FSL and 330 feet FWL, Unit M, Section 32, T-25-S, R-37-E, NMPM, Lea County, New Mexico. In support thereof, Chevron U.S.A. Inc. states the following facts:

- 1) That NMOCD Order No. R-693, effective October 13, 1955, approved a 320-acre Non-Standard Gas Proration Unit in the Jalmat Tansill Yates Seven Rivers (Pro Gas) Pool consisting of W/2 Section 32, T-25-S, R-37-E, for the Arnott Ramsay (NCT-B) Well No. 1
- 2) That on February 6, 1991, Chevron entered into a trade agreement with Doyle Hartman et al whereby Chevron conveyed, among other things, its interest from surface to the base of the Jalmat underlying the E/2 W/2 (160-acres), Section 32, T-25-S, R-37-E, to Doyle Hartman et al.

3) That due to the above mentioned conveyance, the current 320-acre proration unit dedicated to the Arnott Ramsay (NCT-B) well No. 1 should be reduced to 160-acres.

7) The proposed Non-Standard Gas Proration Unit complies with the following provisions:

a) The proposed unit consists of 160-acres that are contiguous.

b) The proposed unit lies wholly within a single governmental section in the Jalmat Tansill Yates Seven Rivers (Prorated Gas) Pool.

c) The entire proposed unit may reasonably be presumed to be productive of gas from the Jalmat Gas Pool.

d) A copy of this application will be sent by certified mail to all offset operators and operators owning interests in the proposed unit's boundary and shall serve as notification.

Attached are plats showing the proposed Non-Standard Gas Proration Unit, the acreage to be dedicated to our Arnott Ramsay (NCT-B) Well No. 1, and all offset operated properties and wells.

In view of the facts submitted, Chevron U.S.A. Inc. requests that administrative approval of the subject 160-acre Non-Standard Gas Proration Unit be granted.

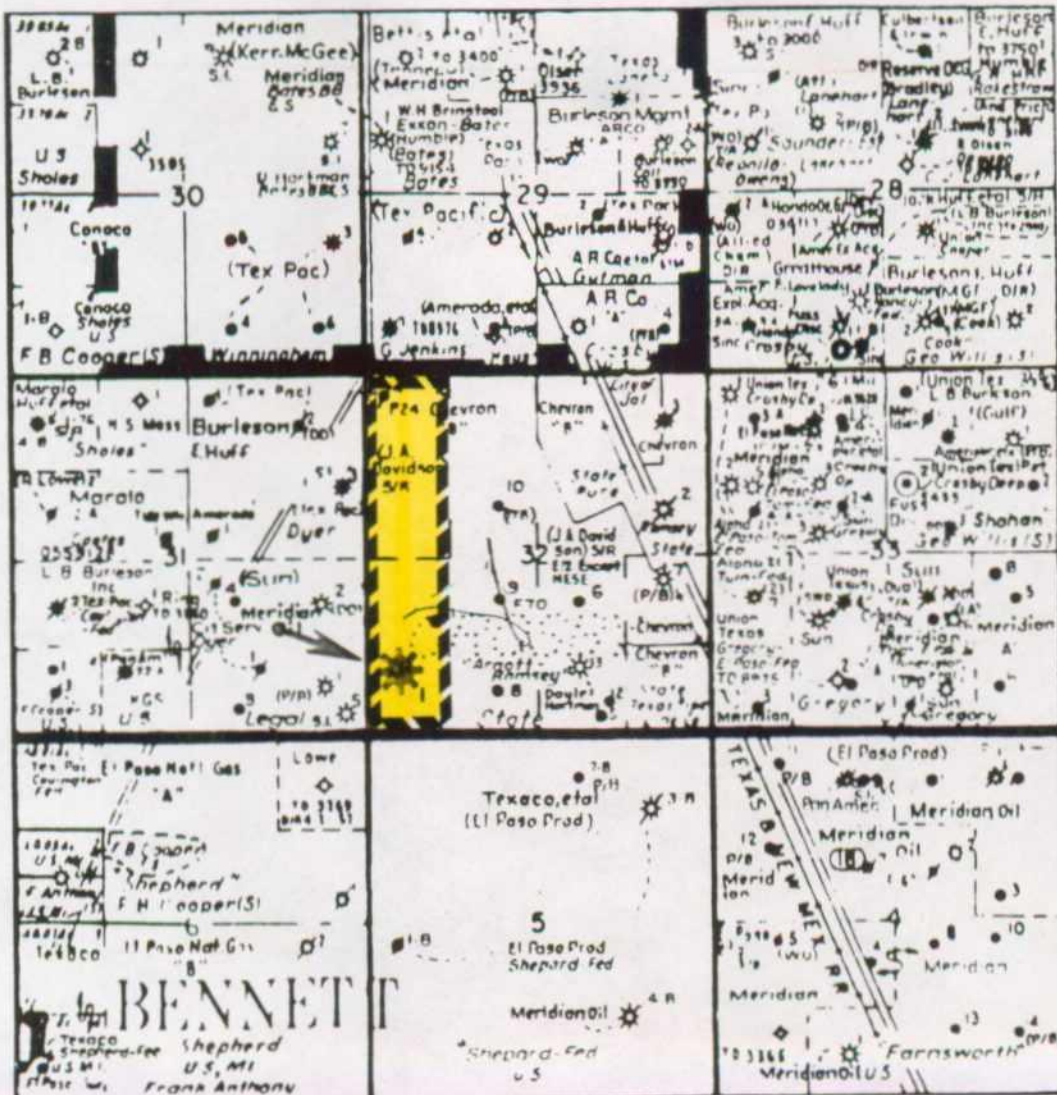

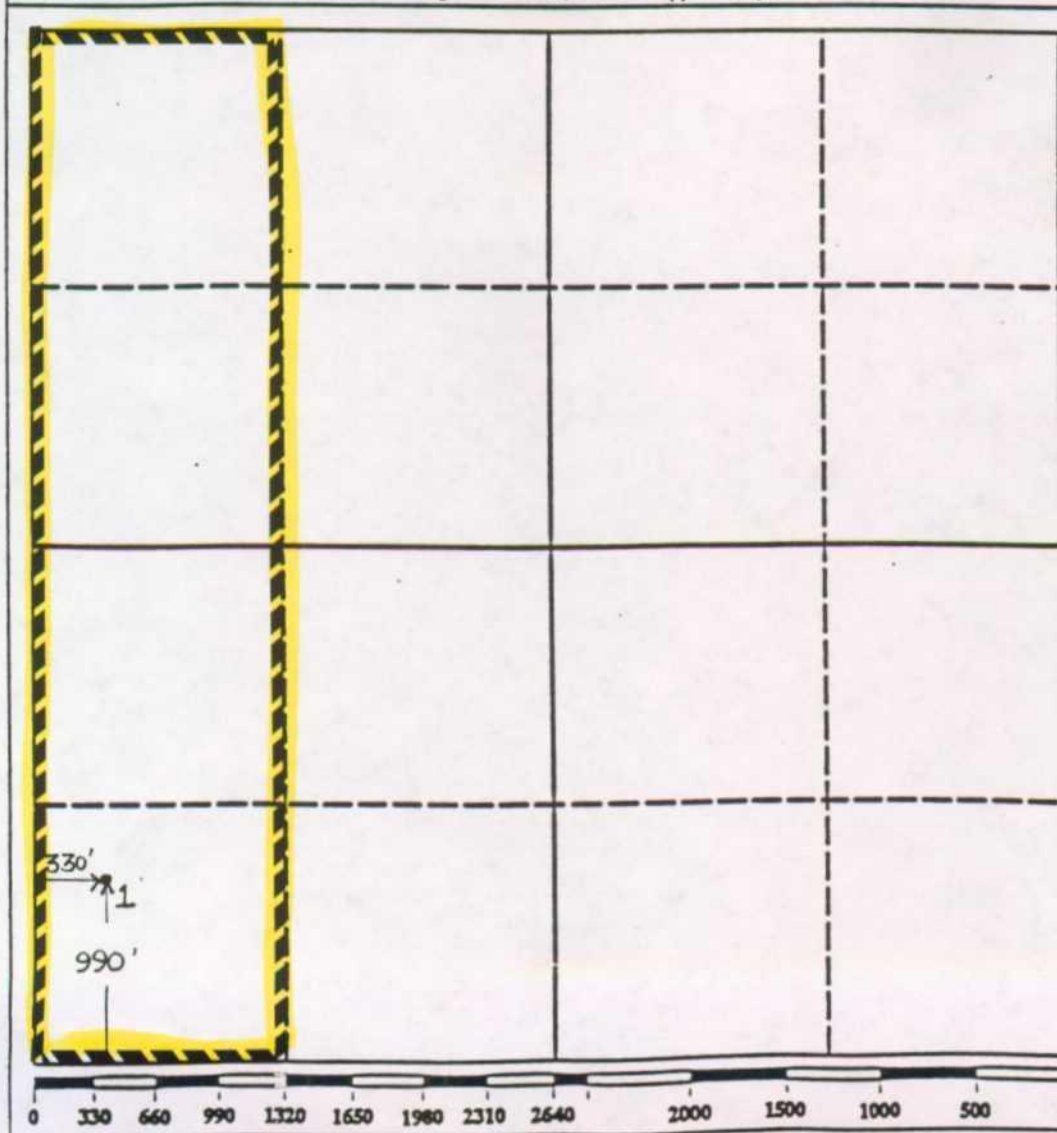

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on June 28, 1955, at Santa Fe, New Mexico, before the Oil Conservation Commission, hereinafter referred to as the "Commission".

NOW, on this 13th., day of October, 1955, the Commission, a quorum being present, having considered the records and testimony adduced, and being fully advised in the premises,

FINDS:

(1) That due notice of the time and place of hearing and the purpose thereof having been given as required by law, the Commission has jurisdiction of this case and the subject matter thereof.

(2) That pursuant to provisions of Rule 5 (a) of the Special Rules and Regulations for the Jalmat Gas Pool of Order No. R-520, the Commission has power and authority to permit the formation of a gas proration unit consisting of other than a legal section after notice and hearing by the Commission.

(3) That applicant, Gulf Oil Corporation is the owner of an oil and gas lease in Lea County, New Mexico the land consisting of other than a legal section, and described as follows, to-wit:

NISP-1583

TOWNSHIP 25 SOUTH, RANGE 37 EAST, NMPM
W/2 Section 32

containing 320 acres, more or less.

(4) That applicant, Gulf Oil Corporation has a producing well on the aforesaid state lease known as Arnott Ramsay "B" Well No. 1, located 990 feet from the South line and 330 feet from the West line of Section 32, Township 25 South, Range 37 East.

(5) That the aforesaid well was completed and in production prior to the effective date of Order No. R-520, and is located within the horizontal limits of the pool heretofore delineated and designated as the Jalmat Gas Pool.

(6) That it is impractical to pool applicant's said lease with adjoining acreage in the Jalmat Gas Pool, and that the owners of adjoining acreage in said area have not objected to the formation of the proposed proration unit of 320 acres.

(7) That unless a proration unit consisting of applicant's aforesaid acreage is permitted, applicant will be deprived of the opportunity to recover its just and equitable share of the natural gas in the Jalmat Gas Pool.

(8) That creation of a proration unit consisting of the aforesaid acreage will not cause but will prevent waste, and will protect correlative rights.

IT IS THEREFORE ORDERED:

(1) That the application of Gulf Oil Corporation for approval of a non-standard proration unit consisting of the following described acreage:

TOWNSHIP 25 SOUTH, RANGE 37 EAST, NMPM
W/2 Section 32

be and the same is hereby approved, and a proration unit consisting of aforesaid acreage is hereby created.

(2) That applicant's well Arnott Ramsay "B" Well No. 1 located in the SW/4 SW/4 Section 32, Township 25 South, Range 37 East, NMPM, Lea County, New Mexico, Jalmat Gas Pool, shall be granted an allowable in the proportion that the above described 320 acre unit bears to the standard or orthodox proration unit for said pool, all until further order of the Commission.
