Reference is made to your application dated May 8, 1995 for a 120-acre non-standard gas spacing and proration unit consisting of the following acreage in the Blinebry Oil and Gas Pool:

LEA COUNTY, NEW MEXICO <u>TOWNSHIP 21 SOUTH, RANGE 37 EAST, NMPM</u> Section 34: NE/4 NE/4 and S/2 NE/4

It is my understanding that this unit is to be simultaneously dedicated to your existing F. F. Hardison "B" Well No. 1 (API No. 30-025-07008), located at an unorthodox gas well location 1980 feet from the North line and 440 feet from the East line (Unit H) of said Section 34 and to your existing F. F. Hardison "B" Well No. 2 (API No. 30-025-07009), located at an unorthodox gas well location 660 feet from the North line and 610 feet from the East line (Unit A) of said Section 34.

By authority granted me under the provisions of Rules 2(a)4 and 2(c) of the Special Rules and Regulations for the Blinebry Oil and Gas Pool as promulgated by Division Order No. R-8170, as amended, the above-described 120-acre non-standard gas spacing and proration unit and

The three 40-acre tracts forming the subject 120-acre non-standard **REMARKS**: gas spacing and proration unit are currently dedicated to the Blinebry interval as follows: (1) the NE/4 NE/4 of said Section 34 in which the No. 2 well is located is dedicated to "oil production", the GOR on the No. 2 well increased to a point that it reclassified as a gas well; (2) the SW/4 NE/4 forming a nonstandard 40-acre Blinebry gas spacing and proration unit (approved by Division Administrative Order NSP-1663, dated March 3, 1993) has dedicated thereon the F. F. Hardison "B" Well No. 3, located 2012 feet from the North line and 1978 feet from the East line of said Section 34, this well is shut-in in the Blinebry interval and is now completed as a gas well in the Tubb Gas Pool; (3) the SE/4 NE/4 forming a non-standard 40-acre gas spacing and proration unit (approved by Division Administrative Order NSP-1615, dated January 22, 1991) has dedicated thereon the subject F. F. Hardison "B" Well No. 1. Both the aforementioned Administrative Orders NSP-1615 and 1663 are hereby placed in abeyance until further notice.

Reference is made to your application dated April 21, 1995 for a non-standard Tubb gas well location for your existing F. F. Hardison "B" Well No. 3 (API No. 30-025-07010) which was originally drilled in 1946 and completed in the Drinkard Pool at a standard oil well location 2012 feet from the North line and 1978 feet from the East line (Unit G) of Section 34, Township 21 South, Range 37 East, NMPM, Lea County, New Mexico. Said well is currently completed as a gas well in the Blinebry Oil and Gas Pool, under authority of Division Order No. NSP-1663, dated March 3, 1993, however said well is shut-in at this time.

It is our understanding that the Blinebry interval will remain shut-in as this well is to be recompleted as a gas well in the Tubb Oil and Gas Pool, which pursuant to the "General Rules for the Prorated Gas Pools of New Mexico/Special Rules and Regulations for the Tubb Oil and Gas Pool", as promulgated by Division Order No. R-8170, as amended, is also unorthodox. Further, the NE/4 of said Section 34 shall be dedicated to the well forming a standard 160-acre gas spacing and proration unit for the Tubb Oil and Gas Pool.
