This well was originally drilled as an oil well in the Bluitt-San Andres Associated Pool at a standard location on a standard 80-acre oil spacing and proration unit. The well currently has a gas-liquid ratio of 30,000 or more cubic feet of gas per barrel of liquid hydrocarbons and therefore has become a gas well as defined by Rule 5 (a) of the General Rules and Regulations for Associated Oil and Gas Pools. Union Oil Company of California seeks approval of the same well location and dedicated spacing unit for this gas well as was previously approved for the well when it was classified as an oil well.


