Dear Mr. LeMay:

Chevron U.S.A. added Yates/Seven Rivers zone to the existing Seven Rivers in the Arnott Ramsey (NCT-D) # 9 in December of 1994. Chevron anticipated a gas well after this completion. An Administrative Application was filed on August 3, 1994 and approved on August 29, 1994 under Administrative Order NSP-1702.

The completion work on the Arnott Ramsey NCT-D # 9 resulted in an oil well instead of a gas well. Therefore Chevron requests that Administrative Order NSP-1702 be rescinded. This would return well # 9 to an oil well with a standard 40 acre oil proration unit consisting of the SW/4 of Section 33, T21S, R37E, Lea County, NM.

Attached is a Form C-102 plat illustrating the proration unit acreage and well location and also attached is Form C-104 and a copy of Administrative Order NSP-1702.


