Chevron U.S.A. Inc. respectfully requests administrative approval for the creation of a non-standard 40 acre Blinebry Gas Proration Unit for the Gulf Sims Well # 1.

Chevron U.S.A. is planning to add Blinebry gas zone perfs to the existing Blinebry completion in the Gulf Sims # 1. The location of the proposed recompletion is 990' FSL and 660' FEL in Section 25, T22S, R37E, Lea County, New Mexico. This well is currently a standard oil well location and will become a non-standard gas well location, as it is only 330' from the quarter-quarter line.

The Gulf Sims # 1 is dedicated to a standard 40 acre Oil Proration Unit which consists of the SE/4 SE/4 of Section 25, T22S, R37E.

Well No. 1 was drilled and completed in 1957 as an Abo producer. The well was recompleted into the Drinkard in 1975. Chevron purchased the well from Summit Energy in 1988 and recompleted the well into the Blinebry Oil in 1989. Production has declined and is now marginal.


