

Dear Mr. LeMay:

Exxon Corporation requests administrative approval of a 40 acre Non-Standard Gas Proration Unit in the Blinebry Oil & Gas (Gas) Pool for the Exxon New Mexico "S" State Well No. 38. The basis for this request is "Special Rules and Regulations" for the Blinebry Oil & Gas Pool, No. 4(b)1. On March 21, 1996, Case No. 11479/Order No. R-10579 established a 159.92 acre gas spacing and proration unit for lots 2, 3 and the S/2 NW/4 of Section 2, T22S, R37E, Lea County. Said unit was simultaneously dedicated to the existing Exxon Corporation New Mexico "S" State Well Nos. 14, 38, and 28 located respectively in Units C, E, and F of Section 2.

Well Nos. 14 and 28 are now Blinebry oil wells and therefore each requires a 40 acre Blinebry Oil & Gas (Oil) proration unit. Well No. 38 requires a 40 acre Non-Standard Gas Proration Unit because the proration units surrounding unit letter "E" are assigned to Blinebry oil wells.

A copy of the C-102 for well Nos. 14, 28, and 38 and offset operator information is attached. Offset operators were notified by Certified Mail, return receipt of this request.
